FROM THE CHIEF OF POLICE AND EXECUTIVE DIRECTOR OF PUBLIC SAFETY

WELCOME TO BOSTON UNIVERSITY

Boston is a unique city. It offers a wide array of cultural, historical, and academic opportunities for Boston University students, faculty members, and employees. Nevertheless, as in any metropolitan area, the issues of crime, crime prevention, and personal safety must be addressed explicitly.

Although our crime rate is far lower than the national average, Boston University is not free of crime. Crimes against property, such as theft of personal property, represent the largest percentage of crime reported to the University's police department. Wallets, book bags, backpacks, laptops, MP3 players, smartphones, and bicycles constitute the bulk of the thefts.

The Boston University Police Department is committed to ensuring the safety of students, faculty, staff, and guests to enhance their experience within our community. Our approach to crime prevention and personal safety is highly regarded by our university and law enforcement peers. Boston University has also received the prestigious Jeanne Clery National Safe Campus Award. However, even the best safety system will fall short without your continued cooperation and commitment to your own safety and the safety of others.

Boston University's unique approach to crime prevention brings each of the University's main operating departments into an integrated safety network. This brochure describes the components of our comprehensive crime prevention and personal safety structure.

Your personal safety at Boston University, and the safety of each member of the community and visitors, is a primary concern and treated very seriously. Thus, the University provides an array of protective measures for you.

- Boston University is patrolled and served by armed, professional, sworn, state-certified, and academy-trained officers, 24 hours a day, 7 days a week.
- The Boston University Police Department meets weekly with University officials as well as with surrounding police agencies to share intelligence and discuss safety concerns for our community.
- The campus has over 100 "blue-light" emergency call boxes on both the Charles River and Medical Campuses, and has an extensive video surveillance and security network system.
- The residences have automatically locking outer doors or security/ID stations.
- The University strictly enforces its visitor and overnight guest policy and rules of conduct.

Boston University's crime prevention and personal safety structure combines professional police patrol and investigative personnel, crime prevention initiatives, and the regular dissemination of

safety information to members of the Boston University community. We are all responsible for creating and maintaining a safe and secure environment for every member of our community. Each one of us can improve our community's welfare by paying attention to our own safety, by reporting crime and unsafe conditions, and by helping others.

There are five important things you can do and abide by to avoid being a victim of theft or a more serious crime:

- 1. Lock your room door when you are asleep or out of the room, even for a few minutes.
- 2. Don't leave personal property unattended anywhere that has public access, such as offices, gyms, libraries, cafeterias, classrooms, and the like.
- 3. Always be aware of your surroundings, whether on or off campus.
- 4. If possible, walk with friends when out at night; otherwise use the Escort Security Service. (617-353-4877)
- 5. Report any suspicious activity or persons immediately to the Boston University Police Department. Do not assume they are harmless; trust your feelings. The Police Emergency Number is 617-353-2121 and is located on the back of your Terrier ID card.

In our continuing effort to foster a safe and secure environment, Boston University has improved its emergency response plan and communication systems with the development of an on-demand alert and response system known as BU Alert. In the event of a crisis, such as a building fire, chemical leak, bomb threat, weather-related hazard, or any potential violence from individuals, the University's Incident Command Team has the ability to simultaneously notify students, faculty, and employees of an incident through a variety of electronic means and take appropriate actions in response.

The University takes pride in maintaining an effective public safety program. Our goal is to minimize the incidence of crime and injury. Please help us by reporting anything—however trivial it may appear—that doesn't "seem right." If you see something, say something. Let this be a year in which we all work together to make our campus the safest it can be.



THE BOSTON UNIVERSITY POLICE DEPARTMENT

The Boston University Police Department's mission is to assure the safety and security of all persons and property on the Boston University campuses.

The Boston University Police Department (BUPD) responds to and investigates crimes, maintains order and safety, and enforces Massachusetts laws and University regulations in and around the Boston University Charles River and Medical Campuses. The department is committed to community-based policing. The BUPD is a full-time, professional law enforcement agency that also provides a wide variety of public services—including emergency medical assistance—to the Boston University community. Patrols are conducted throughout the campus area 24 hours a day. Emergency response time is generally under three minutes to any location on campus.



All Boston University police officers are empowered by the Commonwealth of Massachusetts to enforce criminal laws and to make arrests, not only on the campus grounds but also in the areas surrounding the University. They also hold appointments as Deputy Sheriffs of Suffolk County, Middlesex County, and Norfolk County. The prosecution of all criminal offenses are conducted by the prosecuting attorneys of the relevant jurisdiction and typically are addressed in Brookline District Court, Boston Municipal Court, or Suffolk Superior Court.

The Boston University Police Department has an excellent record for the arrest and prosecution of criminal offenders. Our work has received formal recognition from the Boston Police Commissioner and from the Suffolk County District Attorney's office. The department is widely recognized as one of the best-trained and most professional law enforcement agencies in Massachusetts. Members of the BUPD attend community meetings of the many residence associations to provide residents with up-to-date crime prevention information and to hear their concerns about crime and safety issues. The Boston University Police Department is among the few university police departments certified by the Massachusetts Police Accreditation Commission and the Commission on Accreditation for Law Enforcement Agencies.



Boston University's Charles River Campus is located at the intersection of three cities (Boston, Brookline, and Cambridge) within three different counties (Suffolk, Norfolk, and Middlesex). The Boston University Police Department works closely with other local law enforcement agencies, including the Boston Police Department, Brookline Police Department, Cambridge Police Department, MBTA Transit Police Department, county sheriffs, the Massachusetts State Police, and security departments of other area universities, as appropriate. The department has radio communications interoperability through the Boston Area Police Emergency Radio Network (BAPERN) and has access to law enforcement databases as a member agency of the Massachusetts Department of Criminal Justice Information Services. The Boston University Police Department also works with local law enforcement authorities at its Study Abroad locations and other locations outside of Boston as appropriate. The University does not have written agreements with those various law enforcement agencies.

Through coordination with local law enforcement agencies, any reported criminal activity engaged in by students at off-campus locations is monitored and recorded. This information is provided to the Dean of Students for possible disciplinary action.

BOSTON UNIVERSITY MEDIAL CAMPUS DEPARTMENT OF PUBLIC SAFETY

The Public Safety Department provides services and support to the Boston University schools of Medicine, Dental Medicine, and Public Health, and to the Boston Medical Center. The mission of the department is to provide a safe and secure environment for employees, patients,

staff, students, and visitors while minimizing the opportunity for loss of personal and institutional assets. The 125 members of the Public Safety Department are involved in a continuous training program that addresses all relevant aspects of policing and all aspects of Medical Campus operations. Several members of the department are Special Police Officers and, as such, have the power of police officers to make arrests, preserve order, and enforce laws and ordinances in and around the Boston University Medical Campus (BUMC). Other members of the Public Safety Department have the authority to ask persons for identification and to determine whether individuals have lawful business at BUMC. The Department of Public Safety works closely with the Boston University Police and the Boston Police Department. The department has radio communications interoperability with the Boston University Police Department and has access to law enforcement databases as a member agency of the Massachusetts Department of Criminal Justice Information Services.



The department's Investigations Unit is the liaison between the Medical Campus and all external law enforcement agencies. The Investigations Unit also assists agencies responsible for Head of State and Dignitary Protection on Medical Center property.

The Investigations Unit actively participates in BUMC Public Safety Department Crime Prevention Programs through presentations at student and employee orientations, departmental meetings, and with the distribution of crime prevention material. The unit also assists with the coordination of safety awareness programs offered to members of the Medical Campus. The Investigations Unit will provide security surveys and personal protection safety plans when needed.

The Public Safety Department reports to the Executive Director of Public Safety, who reports directly to the Vice President for Administrative Services (617-353-6500). A Government & Community Affairs representative monitors the conduct of Boston University students who live off campus in the Brookline and Allston-Brighton neighborhoods. This representative works with Boston police, obtains information about off-campus student offenses, and meets with and provides assistance to off-campus student residents and their neighbors.

The office is responsible for maintaining working relationships with the City of Boston and the Town of Brookline, as well as the state and federal governments. The staff monitors proposed legislation and regulations that may affect the University community.

REPORTING CRIMES OR OTHER EMERGENCIES

Boston University students, staff, and faculty are urged to report all crimes and emergency situations as promptly as possible, whether they occur on or off campus, to the Boston University Police Department. Prompt reporting will help the department address emergency situations and provide appropriate notice to the University community, where appropriate. Telephone stickers with the emergency number are distributed to residences and to faculty and staff offices. This information is also printed on the back of all Terrier ID cards. *The Boston University Police Department responds to all emergencies on campus, including reports of crime, medical emergencies, suspicious activities, fires, or other hazards. If you believe an emergency situation exists, call the Boston University Police emergency number:* 617-353-2121. If the emergency involves a fire, call 911 first and then the BUPD number above.

If you are on the Medical Campus, you may also call the Public Safety Department Command and Control Center at **617-414-4444**. If you are not on either of the Boston University campuses, you should report any suspected crime or other emergency to local officials.

In addition, students may seek assistance from their own Resident Assistant or other members of Residence Life (resed@bu.edu; 617-353-4380), the Dean of Students office (dos@bu.edu; 617-353-4126), or the University Service Center (usc@bu.edu; 617-358-1818).

The BUPD depends on members of the community to report suspicious behavior and emergencies. Please report any suspicious activity so that BUPD officers may investigate. Additional information about reporting suspicious activities is available at **www.bu.edu/police/crime**.

Boston University encourages all members of the community to report all crimes, including when the victim of the crime elects not to report or is unable to report the crime directly.

Members of the Boston University community and the public at large may provide anonymous tips to the Boston University Police. Anonymous tips may be sent by text to 847411. Type BU <space> and then the message. Standard text messaging rates apply. The message is anonymous and the sender may opt out at any time by texting "stop" to 847411. Boston University's mobile application "BU Mobile" (available for download from iTunes) contains an "Emergency" section that permits you to call BUPD, Student Health Services, the Sexual Assault Response & Prevention Center, or the Escort Security Service with one touch.

SAFETY-RELATED AWARENESS PROGRAMS AND OTHER SERVICES

University Orientation

During the summer and fall, members of the Police Department and the Dean of Students office (Judicial Affairs) deliver safety and security presentations to parents and incoming undergraduate students. These sessions provide information on crime prevention, our various security programs, and what resources are available to all members of the University community. Expectations for student behavior under the Code of Student Responsibilities are clearly defined, with examples provided.

New Employee Orientation

The Boston University Police Department and Human Resources provide crime prevention and safety materials to new employees at the University's orientation program.

Town Hall Meetings

Held throughout the academic year, town hall meetings give students an opportunity to meet with the Chief of Police & Executive Director of Public Safety and the Dean of Students to discuss safety and security on campus. Safety Week

BUPD sponsors Safety Week each fall semester. Held at the George Sherman Union, Safety Week includes RAD demonstrations, computer and bicycle registration, and provides information and resources about a number of other safety issues, including alcohol.

Awareness Programs and Classes

The Boston University Police Department offers the Rape Aggression Defense (RAD) program specifically for women who wish to physically protect themselves against rape and other forms of violence. The 16-hour or the 20-hour course is taught by certified BUPD RAD instructors. The goal of the BUPD RAD program is to provide an easily accessible program of education and awareness for the women of Boston University. The program trains women in basic self-defense and offers them viable options when confronted with various threats of violence. Escort Security Service

The Escort Security Service provides walking escorts to students and employees seven nights a week, from 8 p.m. to 2 a.m. (3 a.m. on weekends). Security escorts are equipped with radios and can communicate directly with BUPD officers. Service is extended during study periods and final examinations.

Medical Campus: 617-414-4444

The Public Safety Department will provide vehicular or pedestrian escorts to the garages, lots, and surrounding Medical Campus buildings during night and weekend hours upon request. Escorts are subject to availability by calling the Command and Control Center at **617-414-4444**.

Domestic and Dating Violence Prevention

The Boston University Police Department provides a full range of services addressing domestic and dating violence issues, including obtaining restraining orders, safety planning, and criminal prosecution.

Bicycle and Pedestrian Safety

The University maintains a dedicated website addressing bike safety on campus and outlining laws and regulations for bikers, drivers, and pedestrians on campus and in the city. Parking & Transportation Services, Sustainability, and the BUPD work together to run campus events promoting bike safety throughout the year. Bike Safety also administers an online bicycle registration program to support, promote, and increase awareness about this important transportation option. Registration is open to all members of the Boston University community. We also strongly suggest you secure your bicycle with the best lock you can afford.






Laptop Registration Program

Offered by the BUPD through STOP (Security Tracking of Office Property), this program enters laptops in a national database and tags computers with an aluminum plate that aids not only in deterring theft but in the return of recovered property. An indelible tattoo is also etched into the cover of the laptop that remains even if the plate is removed. Lifetime registration costs \$10 per computer. Building Security Assessment

To ensure that the physical environment is as safe as possible, specially trained police officers will conduct thorough security assessments of University facilities. Specific recommendations are made based on exhaustive criteria to increase the overall physical security of Boston University facilities.

CRIME PREVENTION AND SAFETY ADVICE

The Five Most Important Things You Can Do to Avoid Being a Victim of a Crime Are:

- 1. Lock your room door when you are asleep or out of the room, even for a few minutes.
- 2. Do not leave personal property unattended anywhere.
- 3. Always be aware of your surroundings, whether on or off campus.
- 4. Report suspicious persons to the Boston University Police Department. Do not assume they are okay; trust your instinct.
- 5. Be clearheaded—no drugs, no alcohol.

Safety in Residences

- Main doors should have an optical viewer.
- Immediately report any strangers in your building or floor to the Boston University Police Department at **617-353-2121**.
- Never permit strangers into a residence.
- Do not sign in anyone who is not your guest.
- Never lend out your room or residence keys to anyone.
- Always lock your room when away, even if only for a minute.
- Inform the residence staff of any lock defects or lost keys.
- Do not attach anything to your key that shows your room number.
- On voice mail or answering machines, never give your name, just the telephone number the caller has reached.

Safety on the Street

- Always be alert to your surroundings.
- At night, walk in well-lit, heavily traveled areas.
- Use the Escort Security Service or walk with a friend.
- Always avoid alleyways and deserted parking lots.
- Never expose cash or expensive items.
- Hold pocketbooks and purses under your arm.
- Be cautious of strangers who approach you and ask for the time or for directions.
- Do not stop if a car pulls up beside you. Get away from the car.
- Use common sense; don't jaywalk.
- Use pedestrian walk lights and crosswalks.
- Never hitchhike.
- Learn the location of Boston University Police Department Emergency Blue-Light Telephones at www.bu.edu/maps.
- Be careful of scam artists. Never accept cash or checks from, or provide check cashing services to, anybody you don't know.

Safety on Public Transportation

- When possible, travel with a companion.
- If you're the only passenger in a subway car or bus, sit as close to the operator as possible.
- In a deserted subway station, stand near the attendant's booth.
- At night, be particularly careful of oncoming traffic while getting off a bus or trolley.
- Utilize the Transit Police in an emergency, at 617-222-1212.

Safety in Off-Campus Housing

- All exterior doors should have good-quality locks.
- The hallways should be well lit.
- An intercom system should work properly.
- Mailboxes should show no signs of tampering.
- Only your last name should appear on your mailbox.
- All windows accessible from the ground level should be protected by bars or grilles.
- Make sure the bars or grating can be opened from the inside in the event of a fire, and that you are given a key if one is required.
- Check your smoke detectors regularly and change the batteries every six months.
- All fire escapes should be enclosed or raised from the ground to prevent unauthorized access.
- Trees or bushes near the building should not be overgrown, and bushes should be kept below window height.

Theft Prevention

Be particularly careful of your personal property when in public places such as dining rooms or libraries.

- Never leave your laptop, pocketbook, or backpack unattended, even for a minute.
- If you must leave your property behind, ask a trusted friend to watch it.
- Never allow yourself to be lured away from your property by a stranger.

Fire Safety

- In the event of a fire, call 911 first and then call the BUPD at 617-353-2121.
- Educate yourself on fire safety by visiting the BU Fire Safety website, www.bu.edu/ firesafety.
- The majority of student fatalities from fire occur in off-campus housing, such as apartments and rented houses.
- Know your escape routes and be familiar with alternative exits in case of fire.

- The use of candles in residences has risen greatly in the past decade and so have candle fires. Fires caused by candles have tripled in Massachusetts over the last 10 years!
- Burning candles in on-campus housing is strictly forbidden.
- Do not leave cooking items unattended.
- Whether you live on or off campus, if for any reason your safety, security, or health is placed at risk due to weather, environmental, or housing conditions, don't hesitate to call the Boston University Police Department; or if it is not an emergency, call the Dean of Students office.



TIMELY WARNINGS, EMERGENCY NOTIFICATION, AND EMERGENCY PREPAREDNESS

BU Alert

Boston University has established a notification system (BU Alert) for the purpose of communicating with the campus community upon the confirmation of a significant emergency or dangerous situation involving an immediate threat to the health or safety of students or employees occurring on the campus. For more information about BU Alert, visit www.bu.edu/ehs/faqs/bu-alert. Students may add or update their BU Alert contact information by visiting the Student Link (www.bu.edu/studentlink) and clicking the "Personal" tab to update "Address and Phone." Questions concerning enrollment in the BU Alert program may be addressed to the Admissions Office (617-353-2300).

Staff may add or update their BU Alert contact information by visiting the BUworks Central Portal (**www.bu.edu/buworkscentral**) and clicking on the "Employee Self-Service" tab, and then selecting "Personal Information" to update "BU Alert Information."

In the event a situation arises—either on or off campus—that, in the judgment of the Chief of Police and Executive Director of Public Safety or his designee, constitutes an ongoing or continuing threat, a "timely warning" will be issued. The warning will be issued through the BU Alert system. Notice may be sent via text message, voice mail, or email. Notice may also be posted on the BU home page, BU web pages, and scrolled on the University's cable television system.

Emergency Response and Evacuation Procedures

Boston University has established emergency response and evacuation procedures to ensure that it is prepared for emergency situations. For more information, visit Emergency Response Planning at www.bu.edu/ehs/comm. That website provides the detailed emergency response plans for severe weather, emergency closings, and instructions for evacuations and sheltering in place. It also outlines the responsibilities of the Emergency Response Team in the event of an emergency. Boston University has been designated as a Storm Ready Community from the National Weather Service (www.stormready.noaa.gov).

Boston University participates in tabletop and other training drills annually, including drills to respond to active shooter situations. Additional information about how to respond in an active shooter situation is available at www.bu.edu/police/safety/shooter/index.shtml.

The Boston University Police Department and Boston University Medical Campus Public Safety Department are the first responders for all emergencies, including police, and medical emergencies. In the event of a fire, call 911 first, and then call BUPD or the BUMC Public Safety Department. BUPD responds to all calls for service and addresses any hazardous situation it encounters during patrol operations or that is reported. BUPD supervisory personnel, in

consultation with University administrators, as appropriate, determine whether there is a significant emergency that requires notification through the BU Alert system.

The Vice President for Administrative Services is the Incident Commander for all confirmed emergency situations and will determine the content of the message and identify the segment(s) of the community to be notified. If the situation warrants immediate action and the Vice President for Administrative Services is not available, the Chief of the Boston University Police or his designee will assume this role. In all cases, Boston University Police Operations is responsible for initiating the BU Alert system and sending the message.

In the interest of safety for the members of our community, the University will initiate the BU Alert system without delay unless the notification will, in the professional judgment of responsible authorities, compromise efforts to assist victims or to contain, respond to, or otherwise mitigate the emergency.

The Public Relations office shall be responsible for dissemination of information to the larger community, including via the University's website (**www.bu.edu**) and *BU Today* (**www.bu.edu/today**).

The Emergency Response Planning Division (ERPD) is responsible for the maintenance, review, and revision of the University's emergency response and evacuation plans and coordinates regular tests of the emergency response and evacuation procedures on at least an annual basis. These tests may be announced or unannounced, and each will be documented with a description of the exercise, the date, time, and whether the test was announced or unannounced. ERPD publicizes the University's emergency response and evacuation procedures in conjunction with at least one test per calendar year. Following every declared emergency or following a campuswide drill, the Director of ERPD evaluates the drill as a means of assessing and evaluating emergency plans and capabilities.

Open Police and Fire Log Laws

Massachusetts law requires all police agencies in the state to maintain open police logs, and federal law requires open logs be maintained by colleges and universities. The public has a right of access to summary information regarding reported incidents. The identification of victims of sexual assault, or attempted sexual assault, is prohibited by law.

The Boston University police and fire logs are available at the police station at 32 Harry Agganis Way. The Medical Campus Public Safety police and fire logs are available at 710 Albany Street.

Federal law requires states to ask every sex offender registered under "Megan's Law" if they are or will be enrolled at or employed by a college or university. State governments will then provide that information to the school's police department or a local police department with jurisdiction for the campus.

Environmental Health & Safety's (EHS) mission is to provide a safe environment for students, faculty, staff, and others visiting our facilities. EHS maintains the University's Fire Log, which is available for inspection at 704 Commonwealth Avenue, Second Floor, and also compiles the annual Fire Safety Report.

ACCESS TO UNIVERSITY FACILITIES

Boston University is private property. The University reserves the right to grant or restrict access to any or all of its grounds, facilities, and programs. During business hours, the University's non-residential facilities on both the Charles River Campus and the Medical Center Campus will be open to students, parents, employees, contractors, guests, and invitees. During non-business hours, access to non-residential facilities shall be limited to authorized personnel only.

ACCESS TO RESIDENCES

The safety of students living in University residences is a preeminent concern of Boston University. The University has a guest and visitor policy for all residences. Specific information concerning the University's Guest Policy and use of Security Assistants is available at www.bu.edu/dos/policies/lifebook/residential, at residence staff offices, or at Residence Life. All large residences have 24-hour security during the semester when students are in residence. Small residences have 24-hour lock and key protection. Additional information about access to University residences is available at www.bu.edu/housing/services/access and information about residence keys is available at www.bu.edu/housing/services/keys.

FIRE SAFETY

If you see smoke or fire, immediately activate the nearest fire alarm system. Call 911 once you have safely evacuated, and then call BUPD at 617-353-2121 or Medical Campus Public Safety at 617-638-4444.

Fire safety is the responsibility of all those within the Boston University community. Environmental Health & Safety develops fire safety programs and works closely with Residence Life to train Resident Assistants and students about fire safety. Boston University is required to annually disclose statistical data on all fires that occur in on-campus student housing facilities.

A fire log is maintained at the Boston University Police Department that includes the nature, date, time, and general location of each fire.

Even in the event that a fire appears to be extinguished, please call **911** first and then notify Boston University Police at **617-353-2110** and Environmental Health & Safety at **617-353-4094**.

When calling, please provide as much information as possible about the location, date, time, and cause of the fire.

Policy

Fire safety is taken very seriously at Boston University, and all residents are expected to cooperate in keeping the residences as safe as possible. For this reason, the following activities are forbidden, and those engaging in them should expect serious consequences:

- Setting fires of any kind for any reason
- Tampering with any fire safety equipment, including fire extinguishers, fire alarm boxes, smoke detectors, and sprinkler heads (such as hanging objects from sprinkler heads, and so forth)
- Malicious activation of a fire alarm
- Propping open fire doors for any purpose other than emergency evacuation
- Use of roofs and fire escapes for any purpose other than for escape from a fire or threat of a fire
- Accidental activation of a smoke detector or fire alarm resulting from hall sports, water fights, and so on
- Lighting open flames, and the possession of candles or incense in the residences
- Using space heaters or other types of portable heaters
- Careless use of approved items/appliances that creates a fire hazard

The following appliances are allowed in dormitory-style residences:

- Radios, tape recorders, stereos, television sets, personal computers
- Reading lamps, hair dryers, electric toothbrushes
- Refrigerators (up to a maximum of four cubic feet), rental MicroFridge units
- Hot-air popcorn poppers
- Fans (no larger than 12 inches in diameter)

The following appliances are **prohibited** in dormitory-style residences:

- Microwave ovens, coffee pots, hot plates, blenders, hot pots
- Appliances for the preparation of food other than University rental program Micro-Fridge units and hot-air popcorn poppers
- Torchère-style halogen lamps, electric blankets, air conditioners, and sunlamps are
 not permitted in any dormitory-style residence. Because of safety and health concerns, use of electrical appliances other than those listed above is prohibited. Additionally, the use of items/appliances which have a source of heat or flame is also
 prohibited.

Student Residences

Boston University commits to providing housing to all students for all four years of undergraduate education and provides campus housing to more than 11,000 students.

Facilities Management & Planning is responsible for the maintenance and testing of fire safety systems including detection devices, suppression systems, and fire extinguishers. Environmental Health & Safety is responsible for auditing those maintenance programs and ensuring compliance with regulations or policy. BU contracts with third-party vendors to conduct required testing of alarm, suppression, and extinguishing systems; Facilities Management & Planning inspects fire extinguishers, egress pathways, emergency lighting, and exit signage on a monthly basis.

Boston University upgrades life safety systems during scheduled construction and renovation projects and allocates additional funding each fiscal year for the installation or upgrade of existing life safety systems as determined necessary. Boston University maintains its buildings at or above current regulatory requirements.

Fire Safety Training

Prior to the start of each academic school year, Environmental Health & Safety trains each of the nearly 350 Residence Life staff members on general fire safety, procedures, policies, and how to properly evacuate a building. Within the first week of the full student move-in, Residence Life staff members meet with their respective residences by floor or building to discuss the fire safety policies, rules, and evacuation procedures.

In addition to this annual mandatory training, each residential building is affixed with building-specific evacuation plans and evacuation floor maps. Each floor of a given residential building is provided with a building-/floor-specific map and plan. The plan highlights the University's evacuation plan, building-specific meeting points, and emergency contact information.

The University's evacuation plan is known as R.A.C.E., which stands for:

RESCUE/REMOVE—PERSON(S) FROM IMMEDIATE FIRE SCENE OR ROOM

CONFINE—THE FIRE BY CLOSING ALL DOORS

EXTINGUISH—A SMALL FIRE BY USING PORTABLE FIRE EXTINGUISHER OR USE TO ESCAPE FROM LARGE FIRES. **EVACUATE** THE BUILDING

Fire safety training at BU includes instruction on fire alarm pull station locations, evacuation meeting points, shelter in place, sprinkler and smoke detector activations, and fire extinguisher basics, including their location.



FIRE SAFETY REPORT

Emergency Response

Boston University has 24-hour dispatch centers for Facilities Management and for Police/Public Safety at each of its campuses. These dispatch centers utilize a number of communication protocols to activate emergency plans, notify appropriate responders, and then escalate or de-escalate that response as appropriate.

In the event of a fire, call 911 first.

Fires at Boston University are handled by appropriately trained responders only. Residents are trained to activate the fire alarm and evacuate. The first responders from Environment Health & Safety, Facilities, and/or BUPD are responsible for managing a safe response, a controlled environment, interaction with the responding fire department, and recovery and reoccupation when the incident is resolved.

ALCOHOL AND DRUG POLICIES AND DISCLOSURES

Policy on Illegal Drugs and Alcohol

Boston University's campuses and activities are not sanctuaries from federal, state, and local laws. Boston University prohibits the unlawful use, possession, sale, distribution, or manufacture of controlled substances or alcohol on University property or as part of University activities. Boston University's alcoholic beverage policy is consistent with the laws of the Commonwealth of Massachusetts.

However, the University's standards of personal conduct substantially exceed the minimum expectations of civil law and custom. Students found in violation of the University alcohol policy or engaging in misconduct related to the abuse of alcohol, whether on or off campus, will be subject to disciplinary action under the Code of Student Responsibilities as well as to prosecution. Boston University enforces the Massachusetts underage drinking law and state and federal drug laws. The legal drinking age in Massachusetts is twenty-one.

Boston University neither permits nor condones the possession, use, or sale of illegal drugs and narcotics. Violators are subject to University disciplinary procedures, as well as to criminal prosecution under state and federal laws. Dealing in narcotics or illegal drugs anywhere on campus will result in expulsion from the residence system and further disciplinary action by the University. Conviction for drug-related offenses in any jurisdiction may affect a student's eligibility for federal, state, or University financial aid.

The University falls within federal and state Drug-Free School Zone laws.

Violations of drug and liquor laws are reported under the federal Jeanne Clery Disclosure of Campus Security Policy and Campus Crime Statistics Act, and under Massachusetts law.

Standards of Conduct

The unlawful possession, use, or distribution of illegal drugs or alcohol by any student or employee on University property or in conjunction with any University activity is prohibited.

Disciplinary Sanctions

The University will impose disciplinary sanctions on students and employees who violate University standards of conduct. In addition, students or employees who violate public law are subject to criminal prosecution. Conviction may result in fines, imprisonment, and revocation or loss of eligibility to receive federal funding (such as grants and financial assistance) and other privileges.

University-imposed discipline may include sanctions up to and including expulsion of a student or termination of employment, in addition to referral for criminal prosecution. Disciplinary sanctions may include required participation in a treatment, counseling, or other approved rehabilitation program.

Alcohol in University Residences

- 1. Students who are 21 years of age or older and possess a Massachusetts driver's license are currently extended the privilege to possess and consume alcoholic beverages in University residences. Such privileges may be revoked.
- 2. Students who are under 21 years of age may not possess or consume alcoholic beverages in the residences.
- 3. Quantities of alcoholic beverages permitted to be brought into or stored in any residence facility by any resident 21 years of age or older are limited to seventy-two ounces of beer (for example, a six-pack), and one liter of other alcoholic beverage; any substantial quantity of alcoholic beverages (such as beer balls or kegs; cases of beer, wine, or other alcohol) may not be delivered to or brought into residences or other University facilities. Students who bring substantial quantities of alcoholic beverages into the residences will be subject to disciplinary action; this may include, but is not limited to, expulsion from the residences.
- 4. No alcoholic beverages may be served or sold at Boston University functions that are attended primarily by undergraduate students. Applications for exceptions will be considered by the Dean of Students for certain events (for example, a senior class function).
- 5. Alcoholic beverages may not be consumed in any public areas of the University.
- 6. Guests of residents, regardless of age, may not bring alcoholic beverages into University residences.
- 7. The possession and consumption of alcoholic beverages should not be part of an activity that is in violation of a University policy, as stated in the Code of Student Responsibilities and the Residence License Agreement, and such beverages are not to be consumed in any restricted area, such as hallways, lobbies, and common areas.
- 8. The University reserves the right to conduct inspections in appropriate circumstances in order to enforce its policies and confiscate any beverages on University property in violation of this policy.

Proper identification must be presented to University personnel upon request.

UNIVERSITY SANCTIONS

As further clarification of our approach to dealing with illegal use or possession of alcohol, it is useful to understand the typical sanctions in cases where students do not seek medical assistance. The disciplinary sanctions typically imposed for underage alcohol possession and use violations, together with the education and counseling programs that are usually required, are as follows:

Violations in University Residence Halls

Following are the sanctions and education and counseling programs typically imposed for underage alcohol possession and use violations that take place in University residence halls. More serious sanctions may be imposed in appropriate circumstances, including when the quantity of alcohol is excessive (e.g., exceeds one case of beer or one liter of liquor) and when an individual provides alcohol to persons who are under 21 years of age. If other unacceptable behavior—such as fighting, sexual assault, or property damage—occurs in conjunction with the alcohol violation, additional sanctions may be imposed for that behavior. Second violations are uncommon and third violations are rare. Sanctions for a third violation will include, among other things, separation from University housing.

First Incident:

- Disciplinary Sanction: Probation and \$100 fine
- Education/Counseling: an online self-assessment and education on alcohol use

Second Incident:

- Disciplinary Sanction: Deferred separation from University housing
- Education/Counseling: Alcohol education class

The University permits students who are over 21 to possess and consume alcohol within the residence halls. However, when an excessive quantity of alcohol is present, members of the residence hall staff will contact the Boston University Police Department (BUPD). BUPD determines whether to take action against an individual, including whether to refer the matter to local authorities. (Under Massachusetts law, a minor in possession of alcohol may be arrested and fined and his or her driver's license may be suspended. An individual who buys alcohol for a minor may be fined up to \$2,000 and sentenced to up to six months in jail.)

Violations Not in University Residence Halls

Following are the sanctions and education and counseling programs typically imposed for underage alcohol possession and use violations that do not take place in University residence halls. If other unacceptable behavior—such as fighting, sexual assault, or property damage—occurs in conjunction with the alcohol violation, additional sanctions may be imposed for that behavior. Second violations are uncommon and third violations are rare. Sanctions for a third violation will include, among other things, suspension from the University.

First Incident:

- Disciplinary Sanction: Probation and \$100 fine
- Education/Counseling: an online self-assessment and education on alcohol use

Second Incident:

- Disciplinary Sanction: Deferred suspension
- Education/Counseling: Alcohol education class

Financial Assistance

By federal law, students convicted of drug offenses committed while receiving Title IV federal financial aid may be ineligible for federal financial aid for one or more years from the date of conviction. Resources

Boston University requires every incoming first-year student to take AlcoholEdu for College, an online, non-judgmental, evidence-based alcohol abuse prevention course.

BU STATEMENT ON DRUG- AND ALCOHOL-RELATED MEDICAL EMERGENCIES AND JUDICIAL SANCTIONS

The illegal use or abuse of alcohol or drugs can be hazardous to students' health and safety as well as an impediment to academic and personal success. The University is, above all else, concerned for the safety and well-being of all members of our community; therefore, the University addresses all reported violations of the University's alcohol and drug policies, including notifying the parents of undergraduate students of alcohol- and drug-related incidents, if necessary.

At Boston University, student health and safety are paramount. The University recognizes that alcohol or drug consumption may create medical or safety emergencies in which the potential for University disciplinary action may deter students from seeking assistance for themselves or others. In these situations, we strongly encourage students to act with their own and others' health and safety as the primary concern.

When the University learns of a student's illegal possession or use of alcohol or drugs as a result of that student's seeking medical assistance for him or herself, or another person, that student ordinarily will not be subject to University disciplinary sanctions for possession or use of that substance so long as the student completes all education and counseling programs recommended by the University. We are committed to the use of education and treatment approaches because, in our experience, education and/or treatment for individuals who receive emergency medical attention may reduce the likelihood of future occurrences.

When there is a question of sexual abuse or assault in a situation involving alcohol or drugs, the student who was sexually abused or assaulted is not subject to discipline under the University's alcohol and drug policies.

STATE AND FEDERAL LAWS AND SANCTIONS CONCERNING DRUGS AND ALCOHOL

In addition to disciplinary sanctions imposed by the University, all students, faculty, and staff should be aware that federal, state, and some local laws treat illegal use, possession, sale, distribution, or manufacture of drugs or alcohol as serious crimes. Conviction can lead to imprisonment, fines, and assigned community service. Courts do not lift prison sentences in order to allow convicted persons to attend college or continue their jobs. Felony and certain other convictions can prevent you from entering many fields of employment or professions and may have to be listed on applications for employment or admission to graduate or professional schools.

Many cities and towns in Massachusetts, including Boston, have local ordinances and regulations which prohibit public consumption of alcoholic beverages or consumption of alcoholic beverages on private property without the owner's consent. The Department of Conservation and Recreation also prohibits public consumption of alcohol in its parks. Similar laws and regulations apply in most other states and in many localities.

Massachusetts laws punish sale or delivery of alcoholic beverages to persons under 21 with a fine of up to \$2,000 and six months imprisonment, or both. Misrepresenting one's age or falsifying an identification to obtain alcoholic beverages is punishable by a fine of \$300. First conviction of driving under the influence of alcohol has a penalty of a \$500-\$5,000 fine, one-year revocation of driver's license, up to two-and-a-half years in prison, and mandatory alcohol rehabilitation.

Massachusetts has criminal penalties for use of controlled substances, or drugs, with penalties varying with the type of drug. In general, use of narcotic and addictive drugs, and drugs with high potential for abuse, have heavier penalties.

Possession of drugs is illegal without valid authorization. While penalties for possession are generally not as great as for manufacture and distribution of drugs, possession of a relatively large quantity may be considered distribution. Under both state and federal laws, penalties for possession, manufacture, and distribution are much greater for second and subsequent convictions. Many laws dictate mandatory prison terms and the full minimum term must be served.

Massachusetts makes it illegal to be in a place where heroin is kept and to be "in the company" of a person known to possess heroin. Anyone in the presence of heroin at a private party or in a dormitory suite risks a serious drug conviction. Sale and possession of "drug paraphernalia" is illegal in Massachusetts. Under federal laws and some state laws, participation in drug-related criminal activity can result in seizure or forfeiture of personal property and other assets utilized in conjunction with or stemming from the proceeds of the illegal activity. In addition, conviction of a drug-related offense may entail civil fines and denial or revocation of certain licenses and benefits.

Persons convicted of drug possession under state or federal law are ineligible for federal student grants and loans or for participation in federally sponsored research grants or contracts for up to one year after the first conviction, and up to five years after the second; the penalty for distributing drugs is loss of benefits for five years after the first conviction, 10 years after the second, and permanently after the third.

Under federal law, distribution of drugs to a person under age 21 is punishable by twice the normal penalty, i.e., a mandatory one-year prison term; a third conviction is punishable by mandatory life imprisonment. These penalties apply to distribution of drugs in or within 1,000 feet of a college or school. Federal law sets greatly heightened prison sentences for manufacture and distribution of drugs if death or serious injury results from use of the substance.

Federal Drug Laws

The possession, use, or distribution of illegal drugs is prohibited by federal law. There are strict penalties for drug convictions, including mandatory prison terms for many offenses. The following information, although not complete, is an overview of federal penalties for first convictions. All penalties are doubled for any subsequent drug conviction.

A. Denial of Federal Benefits 21 U.S.C. 862

A federal drug conviction may result in the loss of federal benefits, including school loans, grants, scholarships, contracts, and licenses. Federal drug trafficking convictions may result in denial of federal benefits for up to five years for a first conviction. Federal drug convictions for possession may result in denial of federal benefits for up to one year for a first conviction and up to five years for subsequent convictions.

^{*} In accordance with the requirements of the Drug-Free Workplace Act of 1988, as a condition of employment, any employee who is engaged in the performance of work under a federal grant or contract must notify the University if he or she is convicted of violating any criminal drug statute for activities done in the workplace not later than 10 days after conviction; students who receive Pell and certain other federal grants are subject to similar conditions and must report any conviction of a drug-related offense to the U.S. Department of Education within 10 days of the conviction if the offense occurred during the period covered by the grant.

Federal Drug Possession Penalties B. Forfeiture of Personal Property and Real Estate 21 U.S.C. 853

Any person convicted of a federal drug offense punishable by more than one year in prison shall forfeit to the United States any personal or real property related to the violation, including houses, cars, and other personal belongings. A warrant of seizure is issued and property is seized at the time an individual is arrested on charges that may result in forfeiture.

C. Federal Drug Trafficking Penalties 21 U.S.C. 841

Penalties for federal drug trafficking convictions vary according to the quantity of the controlled substance involved in the transaction. The list below is a sample of the range and severity of federal penalties imposed for first convictions. Penalties for subsequent convictions are twice as severe.

If death or serious bodily injury results from the use of a controlled substance which has been illegally distributed, the person convicted on federal charges of distributing the substance faces a mandatory life sentence and fines ranging up to \$8 million.

Persons convicted on federal charges of drug trafficking within 1,000 feet of a university (21 U.S.C. 845a) face penalties of prison terms and fines which are twice as high as the regular penalties for the offense, with a mandatory prison sentence of at least one year.

D. Federal Drug Possession Penalties

Persons convicted on federal charges of possessing any controlled substance face penalties of up to one year in prison and a mandatory fine of no less than \$1,000 up to a maximum of \$100,000. Second convictions are punishable by not less than 15 days but not more than two years in prison and a minimum fine of \$2,500. Subsequent convictions are punishable by not less than 90 days but not more than three years in prison and a minimum fine of \$5,000.

Illegal Drugs and Alcohol

Massachusetts Marijuana Law

On January 2, 2009, the Commonwealth of Massachusetts enacted a change in the law regarding the possession of marijuana. The new law amends the possession of one (1) ounce or less of marijuana or THC from a criminal offense to a civil infraction, punishable by a \$100 civil penalty and forfeiture of the contraband. The law does not change the criminal status for those offenders who are in possession of marijuana or THC that exceeds one (1) ounce.

Offenders who are found to be in possession of one ounce or less of marijuana or THC will receive a civil citation to appear in court. The marijuana or THC will also be seized. Offenders do not have to appear in court if they choose to pay the fine before their assigned court date.

If the offender is under the age of 18, parents or legal guardians will be notified, and he or she will also be required to complete a drug awareness program within one year of the offense, with enhanced penalties for failure to comply.

It is very important to understand that possession of one ounce or less of marijuana or THC is still illegal in Massachusetts and is a violation of the Boston University Code of Student Responsibilities. Consequently, offenders remain subject to sanctions from the University along with the civil penalties prescribed by the Commonwealth of Massachusetts.

Description of Health Risks

Serious health and personal risks are associated with the use of illegal drugs and abuse of alcohol. They may include temporary or permanent physical or mental impairment, injury, or death. Use and abuse of such substances may also give rise to conduct which causes injury, death, or damage to the user/abuser or to the person or property of others, resulting in criminal or civil prosecution and liability. Use and abuse of such substances may also lead to unsafe and/or nonconsensual sex, unwanted pregnancy, and may cause defects, injury, or death in unborn children. Consequences also include temporary or permanent loss of educational or employment opportunities.

Drugs and the Body

Narcotics (Heroin):

- Initial euphoria followed by drowsiness and nausea
- Constricted pupils, watery eyes, dazed look
- Overdose may produce slow, shallow breathing, clammy skin, loss of appetite and weight, and possible death

Depressants (Barbiturates, Tranquilizers):

- Relaxed muscles, calmness, drowsiness
- Confusion, disorientation, slurred speech
- Overdose may produce shallow breathing, clammy skin, weak and rapid pulse, coma, and possible death

Stimulants (Cocaine, Methamphetamine):

- Increased heart and respiratory rate, elevated blood pressure, decreased appetite
- Blurred vision, dizziness, insomnia, anxiety
- High doses can cause physical collapse, irregular heartbeat, stroke, and possible death

Hallucinogens (LSD, PCP, Mushrooms):

- Illusions and hallucinations
- Confusion, panic, anxiety, depression, and poor perception of time and distance
- Respiratory failure, death due to careless behavior

Cannabis (Marijuana, Hashish):

- Increased heart rate, bloodshot eyes, dry mouth and throat, and increased appetite
- Interferes with memory, speech, coordination, and perception of time
- Increases risk of lung cancer, weakened immune system, and affects reproductive system

Alcohol and the Body

- Impairment of brain function, judgment, alertness, coordination, and reflexes
- Attitude and/or behavioral changes, such as uncharacteristic hostility, or increased risk taking, such as driving recklessly
- Alcohol taken with other drugs can intensify the effects of the drug, alter the desired effect of the drug, cause nausea, sweating, severe headaches, and convulsions
- Addiction or chemical dependency
- Memory blackouts
- Uncharacteristic family, school, work, or legal problems
- Health problems such as cirrhosis of the liver
- If used during pregnancy, birth defects and mental retardation in users' unborn children may occur



FIREARMS AND OTHER WEAPONS

The possession of weapons of any kind, including replicas, is strictly prohibited on campus. This includes, but is not limited to: firearms, all chemical sprays, knives, and martial arts weapons (for example, nunchaku). The University will impose disciplinary sanctions on students and employees who violate University regulations and standards of conduct regarding weapons. Violations of weapons laws are reported under federal and state law.

Carrying an illegal weapon is a felony punishable by up to five years in state prison. Students or employees who violate public law are subject to criminal prosecution and University sanctions. A conviction for unlawfully carrying a firearm without a license in Massachusetts mandates a one-year jail sentence. Even if one has a valid firearm license, carrying a firearm on a college or university campus in Massachusetts is a crime (with the exception of full-time police officers).

SEXUAL MISCONDUCT

Boston University is committed to fostering a safe learning environment for all members of the University community and preventing sexual misconduct. All forms of sexual misconduct, including rape, acquaintance rape, sexual assault, domestic and dating violence, stalking, and sexual harassment, are violations of Boston University's policies, whether they happen on campus or off campus.

What to Do

If you have experienced sexual assault, you may want to consider taking the following steps:

- **Go to a safe place.** Go to a friend's room, your room, a public place—anywhere you feel you are safe—as soon as you can. If you are concerned about your safety, you can call the Boston University Police Department 24/7 at **617-353-2121** or local authorities, including the Boston Police Department or Brookline Police Department, at **911**.
- Seek medical attention. Medical attention may be necessary to treat the full extent of any injury or trauma and to consider the possibility of sexually transmitted diseases or pregnancy. In addition, a medical exam may be necessary to properly preserve evidence in case you decide to prosecute.

Medical Resources:

The Boston University Police Department has officers who are specially trained and certified to investigate sexual assault cases, and who will investigate all sexual assault crimes that occur on Boston University's campus. The BUPD works cooperatively with local police, who investigate crimes anywhere within their respective cities and towns.

The Boston University Police Department can assist any member of the University community seeking a stay away or restraining order.

- Try to preserve physical evidence. Avoid bathing, brushing teeth, drinking or eating, douching, or changing clothes until physical evidence can be collected. If you change clothes, collect the clothes you were wearing at the time of the assault in individual paper bags (not plastic).
- Contact an experienced counselor. The University's Sexual Assault Response & Prevention Center (www.bu.edu/sarp) provides rapid, confidential, compassionate counseling and assistance to BU students who have experienced a traumatic event, including sexual assault. Counselors are available 24 hours a day and 7 days per week at 617-353-7277.

BU Policies

Boston University's policies prohibiting sexual misconduct are available at www.bu.edu/safety/sexual-misconduct/title-ix-bu-policies. These policies describe the procedures the University follows to investigate allegations of sexual misconduct, the possible sanctions imposed, and protective measures available, and the procedures the University follows in disciplinary cases in order to ensure a prompt, fair, and impartial investigation and resolution.

These policies also describe the safeguards available to those who allege sexual misconduct. If the accused perpetrator is a BU student, the Dean of Students Office may take immediate steps, including relocating the accused student's residence, issuing a "stay away" order to prevent the

accused student from contacting the reporting student, or change course schedules, transportation, dining, or working situations as appropriate.

It is a violation of University policy to retaliate either during or after the investigation of a sexual misconduct complaint. It is a crime to threaten or intimidate a victim or witness to a crime. Any concerns about retaliation, threats, or intimidation should be reported immediately to the BUPD (617-353-2121) or to the University's Title IX Coordinator, Kim Randall (krandall@bu.edu; 617-353-9286).

Disciplinary Procedures

If the offender is a student, the University may impose disciplinary sanctions. Persons seeking to file a complaint should contact:

In cases involving rape, acquaintance rape, sexual assault, domestic violence, dating violence, sexual assault, or stalking, several additional provisions apply, including:

- The accuser and the accused are entitled to the same opportunities to have others present during a University disciplinary proceeding.
- Both the accuser and the accused shall be informed of the outcome of any University disciplinary proceeding alleging a sexual assault.
- Boston University will assist student victims who need to make changes in their academic schedules or living arrangements, provided these changes are reasonable.

University Sanctions

The University sanctions that may be imposed following the final determination of a University disciplinary procedure include suspension and expulsion from the residence system and/or the University for students, and up to and including termination for employees.

Massachusetts Law

Relationship Violence

Under Mass. G. L. ch. 209A, a person suffering abuse from a family or household member may seek a restraining order. Abuse includes attempting to cause or causing physical harm; placing another in fear of imminent serious physical harm; or causing another to engage involuntarily in sexual relations by force, threat, or duress. The term "family or household members" includes individuals who "are or have been in a substantive dating or engagement relationship" as deter-

mined by the Court. The Boston University Police Department (www.bu.edu/police; 617-353-2121) can assist members of the University community who seek a restraining order or other protection offered through the Massachusetts Courts.

Assault and battery are crimes under Massachusetts law. Mass. G. L. ch. 265, Section 13A. An individual convicted of a second or subsequent incident of assault on a family or household member (as defined in Section 209A, above) may be subject to greater sanctions, including up to five years in state prison. Mass. G. L. ch. 251, Section 13M.

Stalking

Under Massachusetts law, a person who (1) willfully and maliciously engages in a knowing pattern of conduct or series of acts over a period of time directed at a specific person which seriously alarms or annoys that person and would cause a reasonable person to suffer substantial emotional distress, and (2) makes a threat with the intent to place the person in imminent fear of death or bodily injury, shall be guilty of the crime of stalking. Mass. G. L. ch. 265, Section 43. The conduct may include threats made by electronic communications such as email, text messages and the like. Stalking may be punished by up to five years in state prison. A person who commits the crime of stalking in violation of an order issued pursuant to Mass. G. L. ch. 209A (among others) shall serve a mandatory minimum of one year in a house of corrections or state prison. A person convicted of a second incident of stalking shall serve a mandatory minimum of two years in a house of corrections or state prison.

Criminal Harassment

Under Massachusetts law, a person who willfully and maliciously engages in a knowing pattern of conduct or series of acts over a period of time directed at a specific person, which seriously alarms that person and would cause a reasonable person to suffer substantial emotional distress, shall be guilty of the crime of criminal harassment. Mass. G. L. ch. 265, Section 43A. The conduct may include communications by electronic means, including email, text messages and the like. Criminal harassment may be punished by up to 2 ½ years in a house of corrections. A person convicted of a second incident of criminal harassment may be punished by serving up to 10 years in state prison.

Counseling and Assistance Services

Student victims of any crime, including sexual assault, rape, acquaintance rape, domestic violence, dating violence, or stalking, are encouraged to avail themselves of the many crisis intervention, counseling, and student services available to them, both on campus and in the community. Students are encouraged to contact a counselor at the Sexual Assault Response & Prevention Center 24 hours a day and 7 days per week (www.bu.edu/sarp; 617-353-7277; sarp@bu.edu). A crisis intervention counselor also is available 24 hours a day and 7 days per week during the academic year through Student Health Services (www.bu.edu/shs;

617-353-3569). Students may also call the Boston University Police Department (**617-353-2121**) or the Dean of Students (**617-353-4126**) for assistance. Employees seeking assistance may contact Faculty & Staff Assistance (**www.bu.edu/fsao**; **617-353-5381**; **fsao@bu.edu**) or the Boston University Police Department (**www.bu.edu/police**; **617-353-2121**) for referral.

Counselors and clergy should report crimes to the Boston University Police Department—unless, in the counselor's or clergy's judgment, it would be inconsistent with the best interests of the student—and may do so confidentially without disclosing the identity of the victim. SEXUAL MISCONDUCT AWARENESS PROGRAMS

The University engages in a variety of educational programs designed to promote awareness and prevention of sexual misconduct, including sexual assault, dating violence, domestic violence, and stalking.

- University Orientation (www.bu.edu/orientation). At BU's Orientation for all incoming undergraduates:
 - o The Dean of Students and representatives from the Judicial Affairs Office discuss the University's Code of Conduct, including the prohibition on sexual misconduct, as well as the University's judicial process for addressing claims of sexual misconduct;

- o The Boston University Police Department discusses student safety, including awareness and prevention of sexual misconduct;
- o The University's Sexual Assault Response & Prevention Center discusses University and area resources;
- o The University's Student Health Center discusses its resources, including STD and pregnancy testing; and
- o The Sexual Assault Response & Prevention Center conducts two skits that teach participants by stander intervention skills, including in the context of sexual misconduct.
- Graduate Student Orientation. At each of the graduate and professional school orientations, the University's Title IX Coordinator or her designee discusses Title IX, sexual misconduct, and the University's policies and resources.
- **New Employee Orientation.** All new employees working at least 75% time are required to attend the BU Employee Experience orientation, which includes information about the University's policies and resources concerning sexual misconduct.
- Faculty/Staff Training. Beginning in the fall of 2014, the University provides online training concerning sexual misconduct for all faculty and staff. The training addresses the types of sexual misconduct, how to have an effective conversation with someone who reports sexual misconduct, University and area resources, and reporting requirements.
- University Information and Materials
 - o **Sexual Misconduct Website.** The University's Sexual Misconduct website (**www.bu.edu/safety/sexual-misconduct**) provides detailed information about sexual misconduct, including what individuals who experience sexual misconduct should do, how to report sexual misconduct, and University and area resources.
 - o Pamphlet. The University distributes a pamphlet entitled "Have You Experienced Sexual Assault, Sexual Harassment, Stalking, or Domestic or Dating Violence?" (www.bu.edu/safety/files/2013/10/DOS-Sexual-Misconduct-Brochure_Final. pdf) to students throughout campus, including to Resident Assistants, student group and club presidents, and Division I athletes, and makes copies available in the reception areas of the Residence Life Office, the Sexual Assault Response & Prevention Center, the Fitness & Recreation Center, the Case Athletic Center, the Judicial Affairs Office, the Boston University Police Department, the Equal Opportunity Office, the Office of the University Ombuds, Student Health Services, the University Service Center, the College of Arts & Sciences Student Academic Life Office, and the Dean of Students Office.
- **Sexual Assault Response and Prevention.** The University's Sexual Assault Response & Prevention Center provides a variety of resources, including:
 - o Confidential counseling services 24/7, free of charge to all BU students, including helping students receive appropriate medical care, identifying resources for academic and personal support, and helping students understand options for reporting and addressing sexual misconduct and the possible consequences.



- o Step Up Step In BU Bystander Training. SARP provides bystander intervention training, which identifies how a bystander can safely and effectively intervene to prevent sexual violence. This program is mandatory for a number of student groups, including all University varsity athletes, student officers of all 550 student organizations, and wellness student volunteers. The program is offered on a monthly basis for faculty and staff.
- o Training to all University Resident Assistants that describes information regarding preventing sexual misconduct, the University's obligations to investigate and report sexual misconduct, and resources available.
- o Teaching a module concerning sexual violence in the popular FY101 course offered in the University's College of Arts & Sciences.
- o Workshops regarding healthy relationships that address intimate partner abuse, including when caring becomes controlling, how to support a friend in a controlling relationship, and how to identify an unhealthy relationship.
- o "Sexual Assault Awareness Week," the White Ribbon Campaign, and other events that are open to the whole University community.
- **Student Health Services.** The University's Student Health Services provides medical and wellness resources, including:
 - o Medical examination and consultation, testing for pregnancy and/or sexually transmitted diseases, and counseling and follow up as needed.
 - o Behavioral Medicine psychiatrists, psychologists, clinical nurse specialists, licensed mental health clinicians, and licensed clinical social workers, who are available to all BU students.
 - o Educational programming concerning sexual health, including sexpert panels, safer sex supplies, the meaning of consent, and healthy relationships workshops. o Information and educational programming concerning interpersonal violence.
- Howard Thurman Center for Common Ground. The Thurman Center, a division of the Dean of Students Office, is committed to preserving the legacy of Dr. Howard Thurman by breaking barriers of divisiveness and building community. It offers a variety of educational programming, including:
 - o The Common Thread podcast, which explores a variety of issues, including sexuality, sexual health, and University resources concerning sexual misconduct.
 - o Courageous Conversations, which focus on issues of race, class, gender, and sexuality, and are designed to equip individuals with skills necessary to engage in sensitive dialogue around these topics.
- Equal Opportunity Office. The University's Title IX Coordinator and Director of the University's Equal Opportunity Office provides a variety of training and educational programming concerning sexual misconduct, including:
 - o Training of all Deputy Title IX Coordinators. Each of the University's schools and colleges and several administrative offices have designated Deputy Title IX

- Coordinators to assist faculty, staff, or students with any issues relating to sexual misconduct. The contact information for all Deputy Title IX Coordinators is available at www.bu.edu/safety/sexual-misconduct/title-ix-bu-policies.
- o Training all Residence Life staff concerning sexual harassment, sexual misconduct, and Title IX.
- o A variety of customized training presentations for faculty, staff, and students designed to meet the needs of particular groups.
- Boston University Police Department. The University's police department provides a
 variety of services and educational programs concerning sexual misconduct, including:
 - o Rape Aggression Defense programs offered for individuals who wish to protect themselves physically against sexual assault and other forms of violence.
 - o Escort Security Services provides walking escorts to students and employees from 8:00 p.m. to 2:00 a.m. seven days per week.
 - o Town Hall Meetings provide students with an opportunity to meet directly with the Chief and members of BUPD and discuss safety and security on campus, including with respect to sexual misconduct.
- **ROTC.** Through the University's Division of Military Education, the University hosts Army, Navy, Air Force, and Marine ROTC programs. At the beginning of each academic year, each class conducts a session on the prevention of sexual assault and harassment using programming provided by the Department of Defense. In addition, the Army ROTC program requires freshmen cadets to review a two-hour video training session on the prevention of sexual assault and harassment at the beginning of each academic year.

SEXUAL HARASSMENT POLICY

Boston University is committed to the principle that no employee, student, or applicant for employment or admission should be subject to sexual harassment. The University strives to provide workplaces and learning environments that promote equal opportunity and are free from illegal discriminatory practices, including sexual harassment.

Sexual harassment is a violation of federal and state laws and University policy, as is retaliation against any individual who in good faith files a complaint of sexual harassment or cooperates in the investigation of such a complaint. Upon receipt of a complaint of sexual harassment or retaliation, Boston University will undertake a fair and thorough investigation, with due regard for the rights of all parties. Every reasonable effort will be made to protect the confidentiality of the parties during the investigation. After an investigation, any person who is found to have sexually harassed or retaliated against another will be subject to discipline, up to and including termination of employment and, if a student, expulsion from Boston University.

Definition of Sexual Harassment

Sexual harassment is defined as sexual advances, requests for sexual favors, and any other verbal or physical conduct of a sexual nature, whether intentional or unintentional, where:

- —an individual's submission to or rejection of the conduct is made, either explicitly or implicitly, a term or condition of employment or of status in a course, program, or activity, or is used as a basis for an employment or academic decision; or,
- —the conduct has the purpose or effect of unreasonably interfering with an individual's work performance, academic performance, or educational experience, or of creating an intimidating, hostile, humiliating or offensive working, educational, or living environment.



Examples of Conduct That May Constitute Sexual Harassment

It is not possible to list all circumstances that might constitute sexual harassment. In general, sexual harassment encompasses any sexually related conduct which causes others discomfort, embarrassment, or humiliation, and any harassing conduct, sexually related or otherwise, directed toward an individual because of that individual's sex. Such conduct is subject to this policy whenever it occurs in a context related to the employment or academic environments, or if it is imposed upon an individual by virtue of an employment or academic relationship.

A determination of whether conduct constitutes sexual harassment is dependent upon the totality of the circumstances, including the pervasiveness or severity of the conduct. The Massachusetts Commission Against Discrimination lists the following as examples of conduct which may constitute sexual harassment:

- Unwelcome sexual advances—whether physical touching is involved or not;
- Sexual epithets, jokes, written or oral references to sexual conduct; gossip regarding one's sex life; comment on an individual's body; comment about an individual's sexual activity, deficiencies, or prowess;
- Displaying sexually suggestive objects, pictures, or cartoons;
- Unwelcome leering, whistling, brushing against the body, sexual gestures, or suggestive or insulting comments;
- Inquiries into one's sexual experiences; and
- Discussion of one's sexual activities.

In order to constitute sexual harassment, conduct must be unwelcome. Conduct is unwelcome when the person being harassed does not solicit or invite it and regards it as undesirable or offensive. The fact that a person may accept the conduct does not mean that he or she welcomes it.

As a university, Boston University, its employees, and students also must be aware of the need for freedom of inquiry and openness of discussion in its educational and research programs, and

must strive to create and maintain an atmosphere of intellectual seriousness and mutual tolerance in which these essential features of academic life can thrive. No university can or should guarantee that every idea expressed in its classrooms or laboratories will be inoffensive to all; pursued seriously, education and scholarship necessarily entail raising questions about received opinions and conventional interpretations. Boston University does guarantee, however, that credible accusations of inappropriate sexual remarks or actions will be investigated promptly, thoroughly, and fairly.

Sexual Misconduct Information and Resources

Employees covered by a collective bargaining agreement: specific provisions of the agreement may provide additional options for addressing a sexual harassment complaint.

Some of the schools and colleges at Boston University have also established their own procedures for handling issues of sexual harassment. Faculty, students, and staff who are members of academic units may contact the office of their dean to determine whether to use these complaint procedures.

Nothing in this policy is intended to limit the authority of Boston University to take appropriate disciplinary action against any individual who violates University rules or policies, whether or not the conduct constitutes sexual harassment under the law or University policy.

HAZING

Boston University expressly prohibits any form of hazing. Hazing is against the law, incorporates other serious crimes, and violates University policy. Reports of hazing will be investigated immediately by the Boston University Police Department, other University administrative offices, outside law enforcement agencies, or any combination of the three. In addition to criminal penalties under Massachusetts law, students or employees are subject to University disciplinary action for organizing or participating in hazing or failing to report persons in danger in conjunction with hazing. General Laws of Massachusetts

Chapter 269: Section 17.

Hazing; organizing or participating; hazing defined

Section 17. Whoever is a principal organizer or participant in the crime of hazing, as defined herein, shall be punished by a fine of not more than three thousand dollars or by imprisonment in a house of correction for not more than one year, or both such fine and imprisonment.

The term "hazing" as used in this section and in sections eighteen and nineteen, shall mean any conduct or method of initiation into any student organization, whether on public or private property, which willfully or recklessly endangers the physical or mental health of any student or other person. Such conduct shall include whipping, beating, branding, forced calisthenics, exposure to the weather, forced consumption of any food, liquor, beverage, drug, or other substance, or any other brutal treatment or forced physical activity which is likely to adversely affect the physical health or safety of any such student or other person, or which subjects such student or other person to extreme mental stress, including extended deprivation of sleep or rest or extended isolation.

Notwithstanding any other provisions of this section to the contrary, consent shall not be available as a defense to any prosecution under this action. (Amended by 1987, 665.)

Chapter 269: Section 18.

Failure to report hazing

Section 18. Whoever knows that another person is the victim of hazing as defined in section seventeen and is at the scene of such crime shall, to the extent that such person can do so without danger or peril to himself or others, report such crime to an appropriate law enforcement official as soon as reasonably practicable. Whoever fails to report such crime shall be punished by a fine of not more than one thousand dollars. (Amended by 1987, 665.)

Chapter 269: Section 19. Copy of secs. 17-19; issuance to students and student groups, teams, and organizations; report

Section 19. Each institution of secondary education and each public and private institution of postsecondary education shall issue to every student group, student team, or student organization which is part of such institution or is recognized by the institution or permitted by the institution to use its name or facilities or is known by the institution to exist as an unaffiliated student group, student team, or student organization, a copy of this section and sections seventeen and eighteen; provided, however, that an institution's compliance with this section's requirements that an institution issue copies of this section and sections seventeen and eighteen to unaffiliated student groups, teams, or organizations shall not constitute evidence of the institution's recognition or endorsement of said unaffiliated student groups, teams, or organizations.

Each such group, team, or organization shall distribute a copy of this section and sections seventeen and eighteen to each of its members, plebes, pledges, or applicants for membership. It shall be the duty of each such group, team, or organization, acting through its designated officer, to deliver annually to the institution, an attested acknowledgement stating that such group,

team, or organization has received a copy of this section and said sections seventeen and eighteen, that each of its members, plebes, pledges, or applicants has received a copy of sections seventeen and eighteen, and that such group, team, or organization understands and agrees to comply with the provisions of this section and sections seventeen and eighteen.

Each institution of secondary education and each public or private institution of postsecondary education shall, at least annually, before or at the start of enrollment, deliver to each person who enrolls as a full-time student in such institution a copy of this section and sections seventeen and eighteen.

Each institution of secondary education and each public or private institution of postsecondary education shall file, at least annually, a report with the regents of higher education and in the case of secondary institutions, the board of education, certifying that such institution has complied with its responsibility to inform student groups, teams, or organizations and to notify each full-time student enrolled by it of the provisions of this section and sections seventeen and eighteen and also certifying that said institution has adopted a disciplinary policy with regard to the organizers and participants of hazing, and that such policy has been set forth with appropriate emphasis in the student handbook or similar means of communicating the institution's policies to its students. The board of regents and, in the case of secondary institutions, the board of education, shall promulgate regulations governing the content and frequency of such reports, and shall forthwith report to the attorney general any such institution which fails to make such report. (Amended by 1987, 665.)

MISSING STUDENT NOTIFICATION PROCESS

Boston University provides students living in University housing on campus the opportunity to provide confidential contact information to the University. Students may identify their confidential contact by visiting the Student Link (www.bu.edu/studentlink) and clicking on the "Personal" tab and updating the "Address & Phone" information to identify a "Missing Person" contact. Students may identify someone other than their emergency contact to be notified in the event the student is determined to be missing and, if students designate someone other than an emergency contact, that individual and his or her contact information will be confidential. This person will be notified in the event the student is officially reported as missing. The Boston University Police Department will investigate every report of a missing BU student and initiate an investigation based on department policy.

If a student for whom a missing person report has been filed has been missing for more than 24 hours, then within the next 24 hours the BUPD will:

- Begin search procedures.
- Notify appropriate law enforcement officials in the Boston area with an administrative message, radio broadcast, or other similar measure.
- Notify the individual identified by the student to be contacted in such circumstances.
- If the student is under 18 years old and not emancipated, notify a parent or guardian.

Depending on different factors surrounding the investigation, certain police actions will occur sooner than 24 hours after confirmation of the original report. For example, when a person under 18 is reported missing, it is investigated as a missing child case and police will immediately make a computer entry into the National Crime Information Center (NCIC) missing persons database and initiate a search. Persons age 18 to 20 must be entered within two hours.

Students, employees, or other individuals who believe that a student living in on-campus housing has been missing for 24 hours may report it to any Residence Life staff member, Resident Assistants, Residential Safety, or to the Boston University Police Department at **617-353-2121**.

All faculty, staff, or students who receive a report of a missing student should immediately report it to the Boston University Police Department.

CAMPUS CRIME STATISTICS

The figures listed in the Campus Crime Statistics tables reflect crimes reported to have occurred on Boston University's Charles River and Medical Campuses as well as the University's non-campus facilities and other Boston University educational programs located outside of the Boston area.

The crime statistics are prepared by the BUPD Crime Analysis & Statistics Unit. Crimes are recorded in the year in which they were reported to a campus security authority. BUPD requests crime statistics from city, state, and other local law enforcement. The crime statistics include crimes reported to Boston University by the Boston Police Department and any other law enforcement that provides responsive information.

Under the Jeanne Clery Disclosure of Campus Security Policy and Campus Crime Statistics Act (Clery Act), the University must report any crimes of which it has knowledge—whether through its police department, non-law enforcement University officials, or from other law enforcement agencies—that occur:

- On campus, with a separate designation for crimes in dormitories.
- In or on certain non-campus buildings or property.
- On certain public property.

The definitions of campus, non-campus building or property, and public property under the Clery Act are as follows:

The term campus means:

- 1. Any building or property owned or controlled by an institution of higher education within the same reasonably contiguous geographic area of the institution and used by the institution in direct support of, or in a manner related to, the institution's educational purposes, including residence halls.
- 2. Property within the same reasonably contiguous geographical area of the institution that is owned by the institution but controlled by another person, is used by students, and supports institutional purposes (such as a food or other retail vendor).

The term *non-campus building* or *property* means:

- 1. Any building or property owned or controlled by a student organization recognized by the institution.
- 2. Any building or property owned or controlled by an institution of higher education that is used in direct support of, or in a relation to, the institution's educational purposes, is used by students, and is not within the same reasonably contiguous geographic area of the institution.

The term *public property* means all public property, including thoroughfares, streets, sidewalks, and parking facilities, that is within the campus, or immediately adjacent to and accessible from the campus.

Both the University's Charles River and Medical Campuses are located in the City of Boston, which is a diverse urban area. There are a variety of properties in and among both campuses owned and controlled by parties other than the University. As a result, the Boston University Police Department and the BU Medical Campus Public Safety Department patrol areas beyond the specific buildings owned or controlled by the University. In addition, the Boston Police Department, the MBTA Transit Police, the State Police, and other local law enforcement agencies also patrol these areas. The University's crime logs include all crimes reported to the BU Police or the Medical Campus Public Safety Department.

Boston University is proud of its long-standing policy of voluntarily reporting its crime indices to the FBI and to the Massachusetts Department of Public Safety. The Boston University Police Department has been commended by the Governor of Massachusetts for its leadership role in making campus crime information available to the public.

Boston University is a community of approximately 35,000 students, faculty, staff, apartment dwellers, and commercial tenants. The University's main campus (Charles River Campus) stretches about one-and-a-half miles along the Charles River, borders the town of Brookline, and is located approximately one-and-a-half miles from downtown Boston. The Boston University Medical Campus is located in Boston's South End, about two miles from the city center.
