Recommendations for Approval:

The CAS Academic Policy Committee recommends approval of the following new certificate:

• A proposal from the Women's, Gender, & Sexuality Program to establish a Graduate Certificate in Women's, Gender, & Sexuality Studies

Summary of Requirements: Successful completion (B- or higher) of four graduate-level courses focused on women, gender and/or sexuality:

- a) GRS WGS 901: Theories and Methods in Women's, Gender, & Sexuality Studies
- b) One of the interdisciplinary team-taught courses offered by the Boston-area Graduate Consortium in Women's Studies
- c) Two courses approved by the Director of Graduate Studies from graduate offerings across Boston University

In addition, candidates for the certificate must participate at least once in an annual pedagogical workshop addressing theoretical and practical concerns associated with teaching WGS. The certificate is available to all students pursuing graduate degrees at Boston University.

Summary of Revisions:

- a) Replace six historical/national categories in which PhD students are required to take one course with the following three broader categories, and require two courses in each category: 1) History of the language/linguistics or medieval literature 1660, 2) Literature in English 1660 1860, 3) Literature in English 1860 present.
- b) Require doctoral students to take a seminar in professional development and advanced writing that prepares them for their post-coursework careers.
- c) Reduce the number of 500-level (combined undergraduate/graduate) courses that post-MA students can count toward the PhD from two to one.
