College and Graduate School of Arts & Sciences Minutes of the Faculty Meeting May 9, 2012

Dean Sapiro began the meeting by asking if there was any Old Business or New Business. There was not. Additionally, no Automatic Consent Items were called up for discussion or vote.

Dean Hughes then brought forth a proposal from the Graduate Academic Affairs Committee (GAAC) to revise GRS policy on the composition of examining committees for final PhD oral exams.

Summary of Revisions: Current policy, dating from when GRS was the only PhD-granting school of Boston University, would be revised (1) to allow all Boston University professorial faculty (not just GRS faculty) to sit on dissertation committees; (2) to require that at least two committee members, including the chair, be faculty members in the student's department or graduate program; and (3) to require that a majority of the committee members be Boston University faculty members. As previously, departments may establish additional rules, and committee membership must be approved by the chair or DGS.

Dean Hughes noted that approximately half of the special appointment requests he signs are for ENG and other BU (non-GRS) faculty. The faculty voted 43 in favor, none opposed or abstaining.

Dean Hughes also noted the GAAC is busy going through bulletin copy.

Dean Sapiro entertained motions to recommend students for graduation in 2012:

- Dean Hughes moved to recommend 201 candidates for graduation with the PhD.
- Dean Jackson moved to recommend 487 candidates for graduation with Master's (MA, MFA, or MS) degrees.
- Dean Jarvi moved to recommend 1828 candidates for graduation with the BA.

All three motions were seconded and passed by acclamation.

Dean Sapiro encouraged faculty to attend Class Day, the PhD hooding, and Commencement. She urged faculty to ensure there would be faculty representation at the hooding ceremony for all departments graduating PhDs, and referred everyone to the Commencement website (http://www.bu.edu/commencement/2012/index.shtml) for more information
