# 2018 Application Guidelines for Blount-Slawson Competition Participants Strings & Piano

Please note that your Blount-Slawson Competition audition can count entirely as your BUTI audition and you do not need to submit any additional materials as a part of your BUTI application.

You may, however, also elect to submit a contrasting work(s) in order to showcase a greater variety of repertoire as outlined in the Audition Requirements on our website for your instrument. To do so, either sign up for a supplemental live audition or upload a supplemental recorded audition in the BUTI application using the instructions below.

#### **OPTION A**

"I plan to use my Blount-Slawson Competition audition on January 27 to count entirely as my BUTI audition."

- 1. Select your program group, or chosen area of study (for example, "violin" or "piano")
- 2. Select "Other (Special situation only)" as your program
- 3. Complete and submit your BUTI application
- 4. Contact the BUTI Office by phone at 617-353-3386 or email at <a href="mailto:tanglewd@bu.edu">tanglewd@bu.edu</a> to notify us that you will be using your Blount-Slawson Competition on January 27 to count as your BUTI audition
- 5. Your competition audition will be recorded by a BUTI Representative and submitted to BUTI Admissions for review alongside your completed BUTI admissions application

#### **OPTION B**

"In addition to my competition audition, I would like to submit a recording of a contrasting work by signing up for a supplemental live audition on January 27."

- 1. Select your program group, or chosen area of study (for example, "violin" or "piano")
- 2. Choose program "Live Audition"
- 3. Complete and submit your BUTI application
- 4. You will receive a separate email confirmation from Acceptd with instructions for scheduling your supplemental live audition in Montgomery, AL during one of the designated available times from 10am to 4pm NOTE: Make sure that your supplemental live audition time does not conflict with your competition time
- 5. Contact the BUTI Office by phone at 617-353-3386 or email at <a href="mailto:tanglewd@bu.edu">tanglewd@bu.edu</a> to notify us that you will be using your Blount-Slawson Competition on January 27 to count as your BUTI audition and have scheduled your supplemental live audition through Acceptd
- 6. Your competition audition and supplemental live audition will be recorded by a BUTI Representative and submitted to BUTI Admissions for review alongside your completed BUTI admissions application

### **OPTION C**

"In addition to my competition audition, I would like to submit a recording of a contrasting work by uploading a supplemental recorded audition to my BUTI application."

- 1. Select your program group, or chosen area of study (for example, "violin" or "piano")
- 2. Choose program "Video Recorded Audition"
- 3. In the Audition section of your application, upload your supplemental recorded audition
- 4. Complete and submit your BUTI application
- 5. Contact the BUTI Office by phone at 617-353-3386 or email at <a href="mailto:tanglewd@bu.edu">tanglewd@bu.edu</a> to notify us that you will be using your Blount-Slawson Competition on January 27 to count as your BUTI audition and have uploaded your supplemental recorded audition to your BUTI application
- 6. Your competition audition will be recorded by a BUTI Representative and submitted to BUTI Admissions for review alongside your completed BUTI admissions application and uploaded supplemental recorded audition
