#### FACULTY news

Recently, Professor Bonnie Costello published "Landscape Poem" in the Fourth Edition of the Princeton Encyclopedia of Poetry and Poetics (Princeton University Press, forthcoming) and "Contesting Modernity at the Kitchen Table: Still Life in the 1920s" in Before the Fall: American Painting in the Twenties (Brooklyn Museum, forthcoming 2011) as well as a translation, "Two Roads" by Guido Gozzano in Literary Imagination (2010). Professor Costello also delivered two conference papers: "Alluding to Painting." Marianne Moore Panel, American Literature Association Convention, San Francisco, May 27. 2010; and "Strange Pictures in My Head: Wallace Stevens in the New York Galleries." Wallace Stevens, New York and Modernism, March 5, 2010.

**Professor Gene Jarrett** has received a Publication Production Grant from the Humanities Foundation to cover certain costs associated with the publication of his forthcoming book, *Representing the Race: A New Political History of African American Literature*, which New York University Press will release in June 2011.

**Professor Magdalena Ostas** published an essay titled "Keats and the Impersonal Craft of Writing" in a collection edited by Larry Peer (from Palgrave Macmillan) called *Romanticism and the Object*. She also gave an invited paper at the inaugural Young Scholars' Workshop at the Duke Center for Philosophy, Arts, and Literature (Durham, NC) titled "Full-Throated Ease: Romanticism and the Concept of Expression," and delivered a paper called "The Tenor of Real Language: Lyric Immediacy in *Lyrical Ballads*" at the annual meeting of the North American Society for the Study of Romanticism in Vancouver, BC, Canada. **Professor Anita Patterson** will be giving a paper at the peer seminar for the T. S. Eliot Society annual meeting on "T. S. Eliot and D. H. Lawrence."

In May, **Professor Matthew Smith** delivered papers in Berlin and Dessau, and his article "Liquid Walls: The Digital Art of Tamiko Thiel" just appeared in the September issue of *PAJ: A Journal of Performance and Art*.

**Mr. Van Anglen** presented a paper in July entitled "Transcendentalism and the Environment: Thoreau's Changing Stance" as part of a panel he organized and chaired ("The Environment: Thoreau as Transcendental Physician") during the 69th Annual Gathering of the Thoreau Society in Concord, Mass. In August, in addition to his other duties as a member of the Board of Directors, he was made Chair of the Standing Committee of the Thoreau Society, with oversight of the Society's extensive archival collections. At the same time, he became a member of the departmental advisory committee of the MIT GeoSpatial Data Center, in which capacity he will help plan a conference in Stuttgart, Germany next March where he will direct a session and do a presentation. His book chapter, "Transcendental Contexts: Greek and Roman Classics" was published as part of *The Oxford* Handbook of Transcendentalism (ed. Joel A. Myerson, Sandra Harbert Petulionis, and Laura Dassow Walls by OUP). He also wrote reviews for Religion and the Arts; and has articles forthcoming in Dante Studies and The Virgil Encyclopaedia (Wiley-Blackwell).
