Federal Direct PLUS Loan Application Instructions 2011-2012

Thank you for your interest in the Federal Direct PLUS Loan Program. In order to review eligibility, please note that there are **THREE** separate steps.

Step one: The student must complete a Free Application for Federal Student Aid (FAFSA). The FAFSA can be completed on-line at <u>www.fafsa.ed.gov</u>. Please list "Boston University" using Federal School Code Number 002130 as a recipient of your FAFSA data. Federal Student Aid Programs will process your FAFSA and forward your data to Boston University. After your FAFSA has been processed, you will receive a Student Aid Report (SAR) from the Department of Education. You should review this report for additional information regarding your aid eligibility, and make any corrections if necessary.

Step two: Enclosed please find the PLUS Loan request form to complete and to authorize the U.S. Department of Education to perform a credit review. The form may be returned to Boston University Financial Assistance at 881 Commonwealth Avenue, Boston, MA 02215 or faxed to 617-353-8200.

Step three: All first time parent borrowers and parent borrowers who secured the loan for the 2010/2011 academic year with an endorser, must complete a PLUS promissory note. All other borrowers will not need to complete a new PLUS promissory note.

The parent borrower must complete the PLUS promissory note online at <u>www.studentloans.gov</u>. The parent borrower will be required to use his/her U.S. Department of Education issued parent PIN to complete the online promissory note. If the parent borrower does not have a parent PIN or cannot recall his/her PIN, please go to <u>www.pin.ed.gov</u> and allow up to 10 business days to secure it.

The PLUS loan cannot be used to settle the student's account until the promissory note has been completed and the parent borrower has a positive credit review. Students with accounts that have not been settled will be unable to complete the registration process and not be eligible for all University services, including moving into a University residence.

BU Financial Assistance 2011-2012 Direct PLUS Request Form

I, the parent borrower, request that Boston University process a Direct PLUS Loan for the 2011-2012 academic year and I consent to allow the U.S. Department of Education and its agents to obtain a report of my credit record and use the information from that report in determining whether to award a Direct PLUS Loan to me. I understand that I will be notified in writing of the results of the credit check with respect to my loan application.

Loan Amount Requested:

- □ I, the parent borrower, understand that if I am unable to meet the PLUS credit criteria and my PLUS application is denied, the student may be eligible for additional Unsubsidized Federal Direct Stafford Loan, in lieu of the PLUS Loan and I **authorize** Boston University to award the student Unsubsidized Federal Direct Stafford Loan up to his/her maximum eligibility which includes \$2000 (Freshmen/Sophomores) or \$2500 (Juniors/ Seniors) per semester in lieu the PLUS Loan.
- I, the parent borrower, understand that if the receipt of my Federal Direct PLUS Loan creates an overpayment on the student's account, Boston University may issue a disbursement of those funds co-payable to me, the PLUS Loan borrower, and the student on whose behalf I am borrowing. I also understand that Boston University will release PLUS Loan funds directly to the student payable to the student only if, by checking this box, I authorize the University to do.
