Satisfactory Academic Progress for Financial Assistance Appeal Form

Overview:

Boston University Financial Assistance is required by federal regulation to ensure students receiving financial aid are making academic progress towards completing their degree. For this reason, your Boston University academic transcript is reviewed each semester to verify that you have completed the required number of credits and maintained the minimum grade point average to continue receiving financial aid, including credit-based educational loans. If your academic performance has fallen short of these standards and you would like to appeal that determination, you must complete the attached Satisfactory Academic Progress Appeal Form. Please note that credits and grades earned at institutions other than Boston University are not considered in the GPA calculation. BU Financial Assistance will begin reviewing complete appeals over the summer, in the order in which they are received. You may be asked to supply additional information in support of your appeal. Satisfactory Academic Progress Standards:

Minimum Credit Hours

- Full-time students must successfully complete a minimum of 12 Boston University credits in each semester in which they are enrolled.
- Generally, all students must complete at least 75 percent of the total credits for which they enroll whether they are enrolled part time or full time.

Minimum Grade Point Average

Students at all grade levels must maintain a minimum cumulative grade point average of 2.00 for renewal of federal, state, and Boston University financial aid, and for certification of all credit-based loans.
