About the Conference

Fiduciary law is designed to encourage people to rely on experts and other fiduciaries, to facilitate fair and efficient terms of those relationships, and to prevent (and provide remedies for) abuse of power entrusted to the fiduciary. This Conference highlights the nature and scope of fiduciary law, and its relationship to other legal doctrines and categories; considers how fiduciary law can be illuminated by viewing it through the lens of such disciplines as economics, psychology, history, political science and philosophy; investigates current debates about recognizing fiduciary duties in the determination of executive compensation, in the prohibition of insider trading under the federal securities laws, in the largely unregulated world of securities and mortgage broker-dealers and in modern capital structure and governance; and explores whether addressing and redressing abuse of power by public officials raises similar issues.

About Professor Tamar Frankel

Michaels Faculty Research Scholar and Professor of Law Tamar Frankel is an internationally renowned expert in the areas of financial system regulation, fiduciary law, and corporate governance, and has been a member of the BU School of Law faculty since 1968. She is the author of the forthcoming *Fiduciary Law*, to be published by Oxford University Press, and she has published a number of significant books, including: *Trust and Honesty, America's Business Culture at a Crossroad* (also published by Oxford University Press, 2006); *Securitization* (2nd ed. 2006); *Investment Management Regulation* (3rd ed. 2005 with Clifford E. Kirsch); and *The Regulation of Money Managers* (2d ed. 2001) (with Ann Taylor Schwing). She has published more than 60 articles and book chapters, has been a visiting scholar at the Securities and Exchange Commission and at the Brookings Institution, and has taught and lectured at Oxford University, Tokyo University, Harvard Law School and Harvard Business School. A native of Israel, Professor Frankel served as an attorney in the legal department of the Israeli Air Force and an assistant attorney general for Israel's Ministry of Justice.
