After welcoming the new committee members, the Board discussed the following topics:

Diverse student roles in the Dean Search Committee

Dean Muir shared the <u>University policy on the Appointment of Deans</u>. The Board discussed creating student forums to contribute to the search process and the possibility of participation on the Dean Selection Committee. Further information will be available after Provost Jean Morrison meets with the faculty to outline the process for creating the committee and implementing the search.

Pinning ceremony

Jonathan Allen suggested the creation of a pinning ceremony, similar to a coat ceremony in medical schools that can provide a forum for sharing the values of BU Law, creating a shared identity, and having tangible markers that will allow BU Law students and alumni identify each other when in professional events and/or forums. This could be part of Continuing Orientation or done with or after Career Conference.

Professional Name Tags for 2L/3L Students

Students shared an interest in providing professional nametags with 2L and 3L students.

Mental Health Professionals in the School of Law

Mental health and wellness are on-going areas of significant need. Dean Muir shared the difficulties in bringing mental health professionals into the school of law, while noting the resources available at the University and through Lawyers Concerned for Lawyers. Peter shared past efforts by SGA to have mental health professionals added to the School of Law, and noted that it was a complex issue. Other options explored is providing coupons to uber to appointments; find phone-based resources (such as hotlines), and requesting counselors with diverse backgrounds.
