## SignStream License Agreement

Trustees of Dartmouth College & Trustees of Boston University & Rutgers the State University of New Jersey ("LICENSOR") grants to LICENSEE, and LICENSEE accepts, a fully-paid, non-exclusive, and non-transferable license to use the computer software program and associated documentation developed by Boston University, Dartmouth College, and Rutgers University known as SignStream, Version 2.2.2 ("PROGRAM"), upon the following terms and conditions:

1. LICENSEE agrees to pay to LICENSOR a one-time fee of ten dollars (\$10) for a site or individual license. The check should be made payable to "Boston University" and sent with a signed copy of this Agreement to Carol Neidle, MFLL/Linguistics, Boston University, 621 Commonwealth Avenue, Boston, MA 02215, USA.
2. SITE LICENSEE agrees to restrict access to LICENSEE's copy of the PROGRAM to individuals officially affiliated with LICENSEE's institution. LICENSEE agrees not to provide access to LICENSEE's copy of the PROGRAM to other individuals.
3. LICENSEE acknowledges that the PROGRAM is a research tool still in the development stage, and that it is being supplied "as is," without any accompanying services or improvements from LICENSOR. LICENSOR MAKES NO REPRESENTATIONS OR WARRANTIES, EXPRESS OR IMPLIED, AS TO MERCHANTABILITY OR FITNESS FOR ANY PARTICULAR PURPOSE OF THE PROGRAM.
4. Notwithstanding Paragraph 3, above, LICENSOR, at their sole discretion, agrees to make minor updates and corrections to the PROGRAM and make such changes available to LICENSEE (via Internet FTP), when practicable.
5. If LICENSEE publishes a review or critique of the PROGRAM, such critique or review shall clearly state that the PROGRAM is still under development.

7. Upon termination of this license, LICENSEE will promptly return to LICENSOR all copies of the PROGRAM, or destroy them, if so requested.
