The School of Music has made space in Room B26G, located in the basement of 855 Commonwealth Avenue, available for rent during the academic year on a first come, first served basis to double bass majors enrolled in courses for the fall or spring semester. **Rental fees are \$20 per semester** and are payable by cash or check. Space requests will be considered beginning on Monday of the first full week prior to the start of classes.

Double bass majors who are enrolled for the upcoming fall semester may also rent space during the summer for a **fee of \$10**. Requests may be made beginning the last day of classes until June 1. Eligible students may also rent space for the calendar year (**at \$50 per year**) during this time.

Renters of space in the Bass Storage Room must agree to the following Terms and Conditions:

1. The room is to be used for storage only of double basses, stools, and music only.
2. Personal items may be kept in the room only when student is in the building. Personal items may not be kept in the room overnight.
3. Food is not permitted in the room.
4. Practicing or loitering in the room is prohibited. Music stands and chairs are not permitted in the room.
5. Do not attach anything to the walls or door.
6. Do not move storage racks or furniture.
7. The room must remain clean at all times. If the room is not in a clean and working condition when vacated, all users will be assessed a cleaning and/or repair fee. If items remain in the room after the end of the usage period, all users will be assessed a cleaning fee and unclaimed items will be held for 21 days, after which they will be discarded.
8. Users who do not return their issued key upon conclusion of this agreement will be assessed a replacement fee.
9. Rentals for the academic year terminate on the Friday after commencement. Summer only rentals terminate on the third Friday in August.
10. The bass storage room is used at the renter's own risk and neither the School of Music, College of Fine Arts, nor Boston University are liable for any damage, loss, or theft of any item left in the room.
11. The School of Music reserves the right to open and inspect the room at any time.

12. All previously assessed fees must be paid in full prior to entering into a new rental agreement.
13. Users may not simultaneously receive access to this room and rent an instrument locker.
14. Failure to abide by these terms and conditions will result in revocation of room access privileges.
The School of Music reserves the right to revoke access privileges to the room, either individually or collectively, at any time.
15. Policies and fees may change at any time without prior notification to current users.

- Cleaning Fee: \$20
- Key Replacement Fee: \$20
- Repair Fee: minimum \$20 up to cost of repair
