School of Music lockers located in the basement of 855 Commonwealth Avenue are available for rent during the academic year on a first come, first served basis to music majors enrolled in courses for the fall or spring semester and to non-music majors currently enrolled in a BU Bands ensemble. **Rental fees are \$20 per semester** and are payable by cash, physical card, or check.

Due to limited space, the School of Music prioritizes users into categories.

1. Music majors enrolled in current semester
 - a. Locker requests will be considered beginning on Monday of the first full week prior to the start of classes.
2. Non-music majors currently enrolled in a BU Bands ensemble
 - a. Locker requests will be considered beginning on Monday of the second full week of classes.

Music majors who are enrolled for the upcoming fall semester or are participating in an eligible study abroad program may also rent lockers during the summer for a **fee of \$10**. Requests may be made beginning the last day of classes until June 1. Eligible students may also rent lockers for the calendar year (**at \$50 per year**) during this time.

Renters of School of Music lockers must agree to the following Terms and Conditions:

1. The size of the locker issued is based on the storage needs of the user's primary instrument.
2. Rentals for the academic year terminate on the Friday after commencement. Summer only rentals terminate on the third Friday in August. **Non-SOM students must clear out their summer locker the third Friday in August and wait until the start of the 3rd week of Fall classes to request a new one.**
3. Lockers must be in a clean and working condition when vacated or user will be assessed a cleaning and/or repair fee. If items remain in the locker after the end of the usage period, the user will be assessed a cleaning fee and unclaimed items will be held for 21 days, after which they will be discarded.

4. The School of Music provides combination locks for all lockers. Personal locks are not permitted and will be removed.
5. Users who lose their issued lock will be assessed a replacement fee.
6. Lockers are intended for individual use only. Users may not share lockers with others.
7. No hazardous or illegal objects or substances may be stored in lockers.
8. Lockers are used at the renter's own risk and neither the School of Music, College of Fine Arts, nor Boston University are liable for any damage, loss, or theft of any item left in the locker.
9. The School of Music reserves the right to open and search lockers at any time.
10. All previously assessed fees must be paid in full prior to entering into a rental agreement.
11. Locker rental policies and fees may change at any time without prior notification to current users.

Fee Structure (all fees are non-refundable)

- Rental Fee (per semester): \$20
- Rental Fee (summer only): \$10
- Cleaning Fee: \$20
- Lock Replacement Fee: \$20
- Repair Fee: minimum \$20 up to cost of repair
