

# **Boston University** Arts & Sciences Center for Innovation in Social Science

#### Call for Proposals to Support Faculty and Graduate Student Research

<u>The Center for Innovation in Social Science</u> is pleased to issue a call for proposals for small grants to support faculty (tenure-track and full-time lecturers), postdoc, and graduate student research in the social sciences. The grants are intended to help foster new research or enhance in-progress projects. This program is generously supported by the T. Scott Miyakawa Endowment Fund for the Social Sciences. Meet the <u>Summer 2023</u> and <u>Summer 2024</u> recipients to learn about the breadth of projects funded.

Guidelines and instructions for proposals are provided below. *This is a rapid-turnaround process*, to help facilitate Summer and Fall '25 research productivity. **Proposals are due April 25, 2025 by 5:00pm**; decisions will be issued by May 15, and funding starts on or after June 1, 2025. Funding may be used through December 31, 2025. IRB approval for funded proposals must be approved/pending prior to June 1.

## All applications must include:

- 1. Brief description (no more than 1,000 words) of the research project and intended outcomes (e.g., conference presentation, journal article)
- 2. Detailed budget and justification.
- 3. Project timeline
- 4. Statement of other funding support for the research project (where applicable)
- 5. Intended personnel, including student research assistants or research consultants (where applicable).
- 6. Investigator CV

Applications should be prepared as a single PDF file and uploaded to JotForm.

Applicants may submit more than one proposal, although each must be uploaded as a separate submission.

#### *Eligibility:*

- CISS Affiliates (Apply to be an affiliate on our webpage).
- Faculty, full-time lecturers, and postdocs in CAS social science departments or programs (African American Studies, Anthropology, Archeology, History, Political Science, Sociology, Women's, Gender, and Sexuality Studies)
- Graduate students in CAS social science departments or programs (African American Studies, Anthropology, Archeology, History, Political Science, Sociology, Women's, Gender, and Sexuality Studies)
- We will also consider applicants from outside the BU-designated social science departments who are
  doing research that explicitly addresses core questions in the social sciences or uses social science
  methods/theories.

#### Criteria:

Proposals will be evaluated on the basis of the project's significance, feasibility, and demonstrated need for funding. Each grant recipient is required to submit a report to the Center Director within 90 days of completion of the project. Priority will be given to persons who have not previously received CISS funds. Some applicants may be invited to present grant-supported research findings at a Center-sponsored research showcase in AY 2025-26. Recipients will also reference the grant in the Funding Acknowledgements of any publications that result from the funded research.

#### **Undergraduate Research Assistance (Maximum: \$2,000)**

Faculty members, full-time lecturers, postdocs, or graduate students may apply for funds to support undergraduate research assistance. The student may assist with meaningful research activities such as data collection, analysis, or library research during Summer or Fall 2025. Minimum hourly rate is \$15 per hour. The Center can help funded applicants to identify undergraduate research assistant candidates.

### **Research Consultancies (Maximum: \$1,000)**

Faculty, full-time lecturers, and postdocs may use funds to provide honoraria for: (a) *consultant(s) on a book prospectus or manuscript*, or (b) *an expert to provide feedback on a new or revised grant proposal for external funding*. Consultants must be substantive or methodological experts; funds cannot be used to support editorial assistance.

## Travel Awards (Maximum: \$1,500)

Faculty, full-time lecturers, postdocs, and doctoral students may use funds of up to \$1,500 toward travel to (a) present their research at an upcoming professional conference or (b) conduct research off-site (e.g., travel to archives or research sites). Applicants must provide proof that their paper/abstract has been accepted for presentation at a professional meeting. Per University guidelines, funds cannot be used to retroactively pay for completed travel.

# **Training Support Awards (Maximum: \$500)**

Faculty, full-time lecturers, postdocs, and doctoral students may use funds of up to \$500 to defray the costs of training opportunities (e.g., methodological or data workshops). Applicants must provide proof of cost of registration for/participation in the program for which funds are requested. Per University guidelines, funds *cannot* be used to retroactively pay for completed training.

#### **Research Supplies Awards (Maximum: \$750)**

Faculty, full-time lecturers, postdocs, and doctoral students may use funds of up to \$750 towards data/transcription, software licenses, books, participant honoraria/transportation or consumable materials necessary to complete their social science research. Each item or group of items should be listed and justified. For further details on allowable purchases, see <u>visit this page</u>.
