COM CO 575 is a zero-credit, ungraded professional experience required to be completed at least once by all students earning an undergraduate degree from the College of Communication. This applies to students completing the BU Hub curriculum. The purpose of the requirement is to ensure students engage with the field of professional communication, applying their curricular and extracurricular experience to practice.

CO575 can be earned as a stand-alone course number OR in conjunction with another course number. Starting Fall 2022, CO 575 will be added automatically by department administrators for students enrolled in one of the following pre-approved courses for academic credit:

Mass COM: CM 471 Internship, CM 420 Ad Lab, CM421 Ad Lab E-Board, CM 580 PR Lab, CM581 PR Lab E-Board, CM 520 The COMmunicator

JO: JO 400 Newsroom, JO 404 WTBU Practicum, JO 411/412/413 Internship, JO 455 Professional Project, CO 520 Boston Globe Co-Op, JO 546 The Statehouse Program

FTV: FT 493/494 Internship, FT 505 Hothouse Productions, FT 573 BUTV1, FT 574 BUTV2

Students will be enrolled after the add/drop deadline. If a student drops/withdraws from the class, CO 575 will be dropped too.

What additionally counts for CO 575?

Students who do NOT take one of the courses listed above can complete this CO 575 requirement by engaging in one of the following experiences: Boston News Service, Daily Free Press, Patriot League Network Broadcast, an internship not for course credit (which means earning CO575 on its own without simultaneously earning academic internship credit), or by completing a different type of experience approved by their faculty mentor. Following is the procedure for CO 575:

- 1. Once you have an experience lined up and before the W deadline (that is, the last day to drop a class with a W) of that semester, download this form and complete the second page.
- Meet with your faculty mentor to discuss the experience and possible signature approval.
 (The BU Student Link lists your assigned faculty mentor. If no faculty mentor is assigned, please email your major department for an assignment.)
- Submit your form to your department by the W deadline of that semester (for the summer semester, we use the summer II W deadline). Once processed and approved, CO 575 will appear on your schedule.

Additional notes:

- Only students in a College of Communication major are eligible to enroll in COM CO 575.
- COM CO 575 can only be registered during the semester that the approved experience is taking place. CO 575 cannot be retroactively added to a student's schedule.
- CO 575 is repeatable and can be on your academic record for any semester in which you are enrolled at the College of Communication.

Appendix A – COM International Students with Internships Only

Any international student studying on a student visa who pursues an off-campus internship in the United States **must** apply for CPT authorization and receive approval from the ISSO before the internship start date. This is essential to remain in good standing with visa regulations. You should allow up to 10 days for CPT authorization from the ISSO. You can download the CPT form from their website here: https://www.bu.edu/isso/employment-internships/student-off-campus-work-and-training/curricular-practical-training-cpt-f-1/

Before submitting the form to the ISSO, you will need to obtain a signature from a COM faculty or staff member, depending on which course number you are earning:

- If you are earning CO575 credit for your internship, you should submit your CPT form to the COM Undergraduate Affairs office at comugrad@bu.edu.
- If you are earning a 2- or 4-credit academic internship (CM471, FT493/494, JO412, etc), then you will need to receive a signature from the assigned internship coordinator for your major field of study. Please be aware that your internship coordinator will need to sign your CPT form if you are earning both CO575 and an academic internship course number at the same time.

Please be sure that the course number listed on your CPT form is accurate. If you are <u>only</u> earning CO575, this is the course number that should be listed. If you are earning <u>both</u> CO575 and an academic internship course number, you will need to list the academic internship course number and obtain a signature from your internship coordinator.
