A. Personal Statement

I am Professor of Pediatrics and Vice Chair of Health Equity at UMass Chan Medical School (UMass) and UMass Memorial Children's Medical Center. I also serve as Associate Chief Quality Officer for Health Equity at UMass Memorial Health, the second largest health system in Massachusetts. I am a practicing general pediatrician and provide medical care to low-income children. My research focuses on social determinants of health (SDOH), healthcare services, and child poverty. Specifically, my work to date has focused on developing, implementing, and assessing pediatric SDOH screening and referral interventions within the context of health care delivery. My publications have been cited in professional guidelines by the American Academy of Pediatrics and the American College of Physicians, the Centers for Medicare & Medicaid Services' (CMS) Accountable Health Communities project, and the recent reports on Vibrant and Healthy Kids and Integrating Social Care into the Delivery of Health Care from the Health and Medicine Division of the National Academy of Sciences. Overall, I have authored over 70 publications and my work has been cited >2,500 times with >450 citations in 2020.

My research has been continuously funded by the NIH since 2009. I received a Pathway to Independence (K99/R00) career development award which launched my research career. Since then, I have been successful in applying for NIH funding, and currently have R01 awards from the NICHD and NHLBI; I recently completed a R01 award from the NIMHD. I have gained important research skills by successfully administering projects (e.g., staffing, budget, research protections), collaborating with interdisciplinary researchers and community partners, applying for, and obtaining extramural funding, and disseminated findings in peer-reviewed publications and at local, national, and international meetings.

My research career would not have been possible without the mentorship that I received during critical junctures in my career, including fellowship, my first faculty position, my first R01 submission, and in the midcareer stage of my academic career. I am committed to passing this forward to the next generation of health equity clinician-scientists and researchers. I have mentored medical students, public health students, fellows, residents, and junior faculty both at my home institutions (including as an Assistant Dean for Student Affairs) and through my professional organizations. I have directly mentored three junior faculty members who have received their K23 research career development awards on their initial submission. I also love to teach and have received recognition from my learners and peers. Finally, I strongly believe in diversity and inclusion and the urgent need to have more leaders in medicine who are from multicultural backgrounds and have varied lived experiences. As a person of color, to date, I have not had a direct supervising leader who looks like me or is a person of color. I have therefore pushed myself to take on leadership positions to be a part of the solution. In summary, I am honored to be part of this incredible mentoring team.

C. Contributions to Science

- 1. Social Determinants of Health: My primary area of research is focused on addressing the social determinants of health within the context of primary care. Although professional guidelines emphasize the need to address patients' social circumstances, few physicians routinely address these factors at visits. My publications, two of which discuss RCTs including one conducted in eight community health centers (CHCs), found that systematically addressing low-income families' unmet needs increased the discussion of these topics with pediatricians and increased families' receipt of referrals and community-based resources. These publications document the role that clinicians can play in addressing the social determinants within the delivery of primary care. By providing evidence and simple clinical approaches, this body of work has changed the standards of care for health supervision visits, particularly for vulnerable populations. My cluster RCT publication was named one of the Top Stories of 2015 by the New England Journal of Medicine (NEJM) Journal Watch Pediatrics and Adolescent Medicine. Two of my publications were cited in the \$157 million Centers for Medicare & Medicaid Services (CMS) Innovation Center Accountable Health Communities pilot project to test improving patients' health by addressing their social needs. My publications have also been cited in the American Academy of Pediatrics and the American College of Physicians' guidelines on poverty and social determinants in addition to two reports on promoting vibrant and healthy children and integrating social care into health care delivery systems from the National Academy of Sciences. I served as the Principal Investigator in each of the studies below.

- 2. Research Mentoring: In addition to the contributions described above, I mentored medical students and fellows on the medical home at my home institution. Our studies added to the evidence base for the impact of the medical home on child health, particularly for healthy children; we also demonstrated little correlation between two commonly used definitions for the medical home construct. We found socioeconomic and racial disparities in accessing a medical home along with income disparities in the association of the medical home with child health. Finally, we did not find an association with having a medical home attenuating the impact on unmet basic needs on health for low-income children. For these studies, I mentored learners in conducting secondary data analyses using a national dataset. I served as the senior investigator for these studies.

- 3. Family Psychosocial Topics: My earlier work aimed to study the impact of screening and discussion of family psychosocial topics (e.g., parental smoking, substance use, and social needs) at pediatric primary care visits on the parent-provider relationship. It also focused on elucidating pediatric clinicians' attitudes and behaviors towards addressing these topics. These studies demonstrated some key provider barriers to discussing family psychosocial topics at pediatric visits, the impact of training on providers' self-efficacy, and the positive association of discussion of substance use on the parent-provider relationship and behavior change. I served as the Principal Investigator in all of these studies.
