NOTES:

- PASSED** means with a grade of **B- minus** or better in all graduate level courses taken for your degree program. MSQE, MSEPP, ECON+DS and MAGDE students cannot fail more than two courses in their entire program; BA to MSQE and MBA/MSQE students cannot fail more than two courses in the graduate economics part of their programs.
- A student enrolled in three to four-and-a-half courses (12-18 units) will be considered full-time and will be charged full tuition and fees.
- BA to MSQE students should see the undergraduate advisor for questions regarding their undergraduate degree. Effective June 1, 2025: Students must complete all bachelor's degree requirements before enrolling as a master's student, although they may take graduate courses while enrolled as an undergraduate student. Students must register for and earn a minimum of 24 credits while enrolled as a master's student.
- MSQE, MSEPP, ECON+DS, MAGDE, and MBA/MSQE students must submit an electronic Intent to Graduate Form in order to graduate. <http://www.bu.edu/cas/students/graduate/grs-forms-policies-procedures/grs-masters-forms-policies-procedures/grs-masters-graduation-procedures/>
The Intent to Graduate Form is valid only for the graduation date specified; a new form must be submitted if the student does not graduate as planned.

- MBA/MSQE students must file two separate Intent to Graduate Forms. The MBA and MSQE degrees will be conferred concurrently after completion of both programs.
