Follow these easy steps!



PROVIDE



Provide the person with the Title IX Coordinator's contact information:

INFORM



Inform the person that the Title IX Coordinator can coordinate specific actions to prevent sex discrimination and ensure the student's equal access to the recipient's education program or activity.



REFER



If the person needs a reasonable modification or accommodation, refer them to the Equal Opportunity Office.

Depending on the nature of the Student's request, the University may require a Student to provide documentation that is reasonable and necessary to support the Student's need for Reasonable Modifications.
