I. Secretary's Report: Approval of the Minutes

There being a quorum, the minutes of the January 30, 2018 meeting were approved unanimously.

II. Discussion: Health Care Usage Data

Chair Dixon introduced the guests. After a brief review of the population and plan shifts between 2015 and 2016, Dr. Hawkins reviewed the health care utilization analysis rates of 2015 and 2016. The report included annual key quality indicators, i.e. screening rates for breast cancer, colon cancer, diabetic testing and adult well visits. Much of the report focused on utilization among those with chronic conditions. To date, only radiology and outpatient ER visits have shown declines. Other services show mixed results.

A careful discussion about the report followed. Council members asked whether a stratified analysis by employee group (faculty, staff, maintenance workers) could be undertaken. They also asked why an analysis based on income was not done. Dr. Hawkins said that that data is not available to Blue Cross. A Council member noted that the University has that data, but Ms. Tucker said that the University does not supply it to Blue Cross. A Council member asked why employees who are enrolled in the PPO are not eligible for the Health Savings Plan. Ms. Gundogan answered that federal law does not allow employees to enroll in both programs.

Council members were concerned by the fifteen percent (15%) decline among the insured population from 2015 to 2016 and discussed medical coding for purely preventive visits. Council members said that there should be no copay for preventive care and noted examples where they have had a preventive visit and subsequently received a charge after the visit because another condition was noted. The Council suggested that it would be useful to analyze utilization of preventive visits.

Council members asked about maximum out of pocket costs. Ms. Gundogan said that the rate of growth in health care costs decreased from 5-6% to 3-4% from 2015 to 2016, but that is just one year. A Council member asked about the impact of the opioid epidemic on costs. The speakers answered that this data was not included in the report, but it could be included in the future.

A Council member asked about the utilization and costs of preventive screenings. Dr. Hawkins said there has been little change in the utilization and that data was included in the report. The year over year cost increase to enrollees increased 2.5% from 2017 to 2018.

Council members noted that the utilization of mental health services increased from 2015 to 2016. Dr. Hawkins said that, as a population, university employees tend to use more mental health services. He was not sure if this was due to higher levels of stress and depression in the population, or whether they are more comfortable seeking help for mental health problems. Moreover, because they have insurance, they do not face the barriers to mental health services that uninsured populations face.

Council members proposed a plan to examine costs and utilization by employee type and preventive care, to continue to analyze chronic conditions and to look at cost for non-Boston Medical Center available procedures and out-of-pocket drug costs and access to BMC care.

Chair Dixon suggested that the Council form a small ad hoc committee to work with Mr. Nicksa and his team about the direction of health care usage analysis moving forward.

III. New business and adjournment

Chair Dixon asked the Faculty Council if there are topics that it should take up for future discussion.

A Council member asked about the status of Non-tenure Track Review and Promotion. Janelle Heineke, Chair of the Faculty Policies Committee said that the Committee received a charge from the University Provost to analyze the current policies and make recommendations about what should be included in promotion materials for schools and colleges. The Committee has gathered information from all schools and colleges and intends to share its analysis and conclusions with the Faculty Council before completing its report to the Provost. The Committee hopes to finish this work by the end of the semester.

A Council member said that the tuition remission benefit does not include online courses. This is especially relevant to employees on the Medical Campus.

Another Council member asked about mentorship programs for new faculty. Chair Dixon said that mentorship happens on an ad hoc basis on the school/college level, but Faculty Council could take up that topic for discussion and make recommendations.

A Council member asked for an update about gender equity and salary data.

There being no new business, the meeting was adjourned.
