
About PCORI

- An independent research institute authorized by Congress in 2010 and governed by a 21-member Board of Governors representing the entire healthcare community
- Funds comparative clinical effectiveness research (CER) that engages patients and other stakeholders throughout the research process
- Seeks answers to real-world questions about what works best for patients based on their circumstances and concerns

Our Research Focus



We Fund Comparative Clinical Effectiveness Research (CER)



- Generates and synthesizes evidence comparing benefits and harms of at least two different methods to prevent, diagnose, treat, and monitor a clinical condition or improve care delivery
- Measures benefits in real-world populations
- Describes results in subgroups of people
- Helps consumers, clinicians, purchasers, and policy makers make informed decisions that will improve care for individuals and populations
- Informs a specific clinical or policy decision

Note: We do not fund cost-effectiveness research







National Priorities for Health



- Fills patient- and stakeholder-prioritized evidence gaps and is representative and inclusive of diverse and underrepesented patient populations and settings
- Advances the achievement of health equity and elimination of disparities with an emphasis on overcoming the effects on health and healthcare outcomes of racism, discrimination, and bias
- Builds the evidence base for emerging interventions by leveraging the full range of data resources and partnerships
- Examines the diverse burdens and clinical and economic impacts important to patients and other stakeholders
- Focuses on health promotion and illness prevention by addressing health drivers that occur where people live, work, learn, and play
- Integrates implementation science and advances approaches for communicating evidence so the public can access, understand, and act on research findings



This PCORI Funding Announcement (PFA) invites applications for high-quality comparative clinical effectiveness research projects. The Broad Pragmatic Studies (BPS) PFA 2023 funding cycle year will retain familiar requirements from the 2022 standing BPS PFA with updates to reflect PCORI's National Priorities for Health.

The BPS PFA was first issued in January 2022 and combined two longstanding funding opportunities known as the Broad PFA and Pragmatic Clinical Studies PFA. For the 2023 opportunities, PCORI's National Priorities for Health and Board of Governors-approved topic themes have been incorporated.

All applications must align the proposed research with at least one of the four National

How We Review Research Proposals



Our Merit Review Process



- Letter of Intent and a committee of staff members determines which will be invited to submit full applications. Information in the Letters of Intent drives the recruitment of patients, clinicians, scientists, and other members of the healthcare community who have the appropriate expertise to serve on merit review panels.
- Preliminary review of full applications. Reviewers conduct a preliminary review of applications, providing written critiques and scores for the applications based on our review criteria and scoring system.



Our Merit Review Process



- 3 In-person panel review. Following the preliminary review, a subset of applications move forward and are discussed and scored by the full panel of merit reviewers at an in-person meeting. The perspectives of a wide range of reviewers help us choose projects that are important, practical, and relevant to the audiences who will use the results of our work.
- Selection Committee Review. Program staff recommend projects to a Selection Committee that includes members of PCORI's Board of Governors. The committee identifies a slate of applications for possible funding based on merit review scores, programmatic balance and fit, and PCORI's strategic priorities.

This slate is proposed to PCORI's Executive Director for consideration and approval.



What Is Expected of a PCORI Reviewer?



All Reviewers

- Understand and apply PCORI's mission, vision, and review criteria
- Bring experience and perspective that enhances the quality of the review
- Dedicate time and agree to review all assigned applications and participate in a one- or two-day in-person panel meeting

Patient and Other Stakeholder Reviewers

- Ability to represent perspective of broad or specific patient and other stakeholder groups
- Ability to contribute a unique healthcare system perspective

Scientist Reviewers and Chairs

- Advanced degree in a health- or research-related field
- Publication of relevant peer-reviewed articles/studies
- Current or recent funding in a relevant field of study

Engagement Award Funding Opportunities



Up to \$250,000 2 years

Engagement Award: Dissemination Initiative

Objective: Support communities and organizations to actively disseminate PCORIfunded research findings and/or develop partnerships and infrastructure to disseminate and implement PCORI-funded research findings

Up to \$100,000 1 year

Engagement Award: Stakeholder Convening Support

Objective: Convene stakeholders to explore critical issues related to PCOR/CER and/or communicate PCORI-funded research findings to targeted end-users

Up to \$250,000 2 years

Engagement Award: Capacity Building

Objective: Prepare patients and stakeholders to participate as partners in PCOR/CER

PCORI D&I Program Funding Initiatives



Goal: To facilitate the uptake and integration of evidence from PCORI-funded studies into real-world practice, in the context of other relevant evidence

- Limited Competition: Implementation of PCORI-Funded PCOR Results PFA
 - Provides PCORI investigator teams the opportunity to propose next steps to put their findings into practice (up to \$1.5M in total direct costs for Standard Implementation Projects, up to \$3M in total direct costs for Phased Implementation Projects, up to \$300,000 in total costs for Dissemination Projects)
- Implementation of Effective Shared Decision Making Approaches in Practice Settings PFA
 - Promotes the implementation and systematic uptake of shared decision making in practice settings (up to \$1.5M in total direct costs per project)
- Implementation of Findings from PCORI's Major Research Investments PFA
 - Provides a broad applicant pool the opportunity to promote the uptake of peer-reviewed findings from specific, high-priority PCORI initiatives into practice, in the context of related evidence (up to \$2.5M in total costs per project)

Ambassador Program
