Purpose of the Position

Under the overall guidance of the Deputy Representative, accountable for the development, design, planning, implementation and management of the TB and Malaria sub-component of health programme component of the country programme.

As head of the programme, lead and supervise a group of professional and support staff to develop and administer the sub-sectoral programme with a view to integrating gender equality and equity.
