#### **ABOUT THE ORGANIZATION**

Inkomoko identifies 100 Rwandan entrepreneurs each year, and provides them with business education, mentorship, and strategy consulting, so that they can grow their businesses and create jobs for others.

Inkomoko is a member of the African Entrepreneur Collective (AEC), a US-based organization that creates jobs through the development of small and medium enterprises in Africa. Founded in 2012 by social entrepreneurs Julienne Oyler and Sara Leedom, AEC launched Inkomoko as its pilot site and is now expanding across the Continent.

### THE OPPORTUNITY & RESPONSIBILITIES

Inkomoko seeks a highly talented and passionate Managing Director to provide highest quality programming, work effectively with prominent partners and funders, and lead the organization's operations in our office in downtown Kigali. Reporting to the AEC Co-founder and Chief Operating Officer, the Managing Director will be responsible for the Inkomoko's successful operations and growth in Rwanda. Specific responsibilities include:

#### STRATEGY & MANAGEMENT (50% time)

- Supervise and manage all Rwanda-based staff, currently including a talented team of 18 staff from across East Africa, ensuring their effective completion of projects, and helping them achieve their best professional selves
- Seek new opportunities to expand the Inkomoko brand, reputation, and services across the country
- Provide insightful and analytical management updates to AEC management, working as a partner and thought-leader in entrepreneurial innovation
- Lead annual in-country planning processes and staff goal setting, in alignment with larger AEC strategic vision
- Be a leader among leaders in maintaining the organizational culture, professionalism, and highest quality management standards
- Lead all All-Staff meetings, Senior Management team meetings, and participate in Executive Team meetings
- Ensure adherence will all relevant local laws and regulations
- Work closely with AEC Rwanda Trustee Ltd to ensure portfolio performance of the financing fund.
- Provide leadership in the local entrepreneurial ecosystem.
- Work with future AEC sites to best replicate AEC programming.

### FINANCIAL MANAGEMENT & REVENUE GENERATION (25% time)

- Manage the Inkomoko annual budget, taxes, supervising processes for accounting
- Supervise the Operations & Admin Director and accounting staff, including management of monthly reconciliations
- Participate in annual audit process
- Actively solicit new contracts and fee for service engagements that fit our core skills, confirm scope of work, and allocate resources for effective project management.
- Work with AEC to cultivate and steward current and potential donors, including foundations, high net-worth individuals and banking partners.
- Serve as an in-country point-of-contact for institutional contracts, including billing, contract execution, etc
- Participate in the AEC Rwanda Trustee loan fund meetings as a strategic advisor and high-level partner in this earned revenue stream

- Provide high-level support to the client services staff and serve as a point of contact for highest level Programs contracts
- Provide in-country support to Inkomoko's sister organization, African Innovation Prize
- Systems development for Inkomoko client services
