#### President's Report

- a. Constitutional Review: Based on previous discussions on concerns regarding grant eligibility, we decided to do a review of the Constitution (2019) and update it.

- d. 2nd Meeting in voting for a new constitution, last meeting vote was 18 yes and 1 no (vote needs to be unanimous)
- e. Main Changes/Updates to the Constitution:
  - -Departmental Good Standing: 3 meetings based on either the previous or current semester.
  - -Before: Lacked clarity, departmental good standing solely based on the current semester.
  - -Involvement: All grad students are able to attend meetings/events (not just GRS). However, official membership/voting is limited to GRS (including grant eligibility).
  - -Number of Representatives per Department: 2 + 1 alt regardless of department size.
  - -Before 1-3 based on size.
- f. Vote to change the Constitution (2024), 2<sup>nd</sup> Meeting:

YES: 19 out of 20 NO: 1 out of 20 Did NOT pass

- g. Students have attempted to establish new graduate student organizations on campus and have faced several difficulties.
  - -GRS has claimed that there is no way to fund or recognize other organizations.
  - -Only GRS organizations are GWISE and GSO.
  - -GRS had also suggested new clubs request funding from GSO.
