



Qualified Default Investment Alternative (QDIA) Annual Notice for the Boston University Retirement Plan and the Supplemental Retirement and Savings Plan

The information below is provided to those Plan participants who have investments directed into the Plan's Designated Default Fund, a Vanguard Target Retirement Fund.

Under the Plans, any contributions for which Plan Participants do not provide investment direction will be invested in the Plans' designated default investment option, which are the Vanguard Target Retirement Funds.

You have the right under the Plans to direct the investment of your existing balances, which includes contributions and any earnings on those contributions, and your future contributions to any of the Plans' available investment options. In the event that you have not made an investment election, or the Plan Sponsor has not provided direction for a given contribution, your contributions and earnings will be invested in the Plans' designated default investment option, a Vanguard Target Retirement Fund. If your contributions are initially invested in the designated default investment option, you have the right to transfer out of the designated default investment option to another investment option at any time.
