RESEARCH STATEMENT

I study the ways in which racial subordination and the subordination of other marginalized groups manifest in civil procedure, remedies, and federal courts. My scholarship challenges the dominant understanding of these three areas of law as neutral and technocratic. Instead, I contend that civil procedure, remedies, and federal courts are sites where racial hierarchies, and hierarchies along other axes of identity, are embedded within law.

My current projects bring critical race theory, and other critical perspectives, to bear on civil procedure and remedies doctrine to understand how these areas of law contribute to the subordination of marginalized groups including people of color, Indigenous peoples, women, those who are LGBTQIA+, people with disabilities, immigrants, and religious minorities.
