- Currently serve as the chief academic, budget, policy, strategy, and administrative leader at Boston University School of Law (BU Law).
- Achieved our highest LSAT median (from 165 to 170) and GPA median (from 3.73 to 3.86) while also increasing the racial diversity of the student body (African American/Black, Asian American, Latine/x, and Native American students) by approximately 15-17% overall.
  - Increased the law school's overall *U.S. News and World Report* ranking 6 spots from #23 to #17 in spring 2023 rankings, which was its highest ranking ever.
- Accomplished the highest ever job placement rates in bar-passage-required and J.D.-advantage positions for our students at graduation and 10 months after graduation.
- Hired more than 30 full-time faculty since arrival in August 2018, including several firsts who contribute to the diversity of the faculty.
- Leading celebration of 150th anniversary for School of Law in 2022-2023, including highly successful Gala on October 1, 2022, and guiding work in taking newly endowed Barbara Jordan Speaker Series on Race, Law, and Inequality on the road throughout the country.
- Secured major gifts, including a \$3 million gift for a historic (first ever) professorship/chair in Critical Race Theory in nation, \$6 million dollar bequest, and \$3 million dollar bequest for law libraries. Bested annual fund record every year.
- Created Associate Dean for Equity, Justice, and Engagement (ADEJE) role, which is a position held by faculty member and which focuses on improving classroom climate; strategizing with the Dean on the recruitment of a more diverse faculty; and collaborating with the Director of Diversity, Equity, and Engagement, who is located in Student Affairs.
- Developed and unveiled the ASPIRE (Antiracist Scholars for Progress, Innovation, and Racial Equity) Program, a full-tuition cohort scholarship for law students with a demonstrated commitment to antiracism, in collaboration with the University's first-of-its-kind Center for Antiracist Research.
- Launched Summer Pre-Law Academy in collaboration with Law School Admissions Council to enhance the diversity of the legal profession.
- Launched a complementary digital version of the magazine to publish more relevant content year-round, increasing engagement rates nearly 50%.

- With the generosity of a donor and continuing donations, created the Access Fund, which is designed to address some of the ways in which the law school reinforces socioeconomic inequities that can deprive students of equitable access to the education we provide and to post-graduate opportunities in law.
- Launched a first-of-its-kind Compliance Policy Clinic, a central component of our unique Risk Management and Compliance concentration.
