# **Graduate Tax Program**

BU Law's Graduate Tax Program (GTP), established in 1959 as one of the nation's first graduate tax programs, stands as one of the best. Employers value the BU Law LLM credential because it signals rigorous training and superior preparation.

### **Curricular Choice** with Credit-**Granting Skills** Courses

The GTP offers multiple paths to complete the 24 credits required for the BU Law LLM in Taxation degree, with one of the most expansive tax law curricula available.

- Only five required courses
- More than 35 challenging elective courses

  - International Tax
  - General Business Taxation
- Credit-granting skills development courses in the skills and systems you use as a tax lawyer, including Excel

## Choose Your Tax LLM

#### **FULL-TIME RESIDENTIAL**

Our full-time residential option is designed to be completed in one academic year. For recent JD graduates looking to obtain both the theoretical knowledge and practical skills needed for a successful career in tax law, this is an ideal option.

#### **PART-TIME RESIDENTIAL**

If you are a lawyer working within commuting range of Boston and aspire to augment your tax law knowledge and qualifications, the LLM program is open to you on a part-time basis. All residential classes are scheduled during the late afternoon and evening. As a part-time student, you may enroll for up to eight consecutive semesters to complete your degree requirements.

#### **ONLINE**

The Graduate Tax Program offers the same challenging program of LLM studies in an entirely online format, an attractive alternative for domestic and international lawyers whose jobs preclude them from attending classes in Boston. You can begin the program during any of the three online sessions-fall, spring, or summerand enroll in a variety of tax courses taught by the same highly experienced instructors who teach our residential courses. You can complete your degree in as few as two sessions.

## The GTP Network and Student Life

Every student, both online and residential, receives individual guidance and support on all matters, large and small, from the GTP staff. Residential students are connected with other students outside of class through a range of special lectures and community events. Online students contact the tax program staff, teaching assistants, or course instructors with questions about exams, coursework, and other related matters.

All students, residential and online, are a part of the nationally known GTP Network, which connects current students, alumni, faculty, and staff.

# **Degree Requirements**

- 24 credits (12 courses), with five required courses.
- May be completed on a full- or part-time basis.
- For internationally trained lawyers, a three-semester bar qualification option is available.

### Admissions

#### **SCHOLARSHIP OPPORTUNITIES**

Applicants to the Graduate Tax Program's residential option are automatically considered for merit-based scholarships through one of BU Law's LLM Scholars programs. No additional forms or documents are required. Scholarships come in the form of partial tuition waivers. Recipients are notified of their awards at the time of admission. Applicants to the Graduate Tax Program's online option are not eligible for scholarships.


#### **APPLICATION REQUIREMENTS**

Qualified applicants hold a JD degree from an American Bar Association-accredited law school or an equivalent first degree in law from a comparably recognized law school or law faculty outside the United States. International applicants must be highly proficient in English. Online students are held to the same admission standards as residential students.
