BU Law's Executive LLM in International Business Law Program brings together a **global network of legal and business professionals** with subject matter experts and internationally renowned legal scholars. The practice-based curriculum is focused on the key doctrines of international business law from a US perspective. ### **Focused curriculum with a flexible design.**

The Executive LLM curriculum focuses on the essential topics that form the core of an international transaction-based practice.

#### **Blended Courses.**

Blended courses begin with a four-week online session that lays the foundation for a two-week, in-person classroom session offered in Boston and Salzburg. Following the classroom experience is another online session where students work on a final paper and/or capstone project.

#### **Online Courses.**

Fully online courses are offered throughout the year and are typically 14 weeks long. These courses feature dynamic discussion forums, live and recorded classes, and interactive media content.

#### **Practical Training.**

Courses combine practice and skill-based development with doctrine and theory. Course content is always grounded in real-world application.

## Admissions.

### SCHOLARSHIP OPPORTUNITIES

All applicants to the Executive LLM in International Business Law Program are automatically considered for merit-based scholarships through one of BU Law's LLM Scholars programs. No additional forms or documents are required. Scholarships come in the form of partial tuition waivers. Recipients are notified of their awards at the time of admission.

### APPLICATION REQUIREMENTS

The Executive LLM in International Business Law Program is open to candidates with three or more years of work experience. While most applicants are lawyers, a growing number of students come from nonlegal backgrounds, such as compliance and risk management, and highly qualified applicants without law degrees may be considered for admission.

## Degree Requirements.

- 20 credits
- Three required courses: US Contract Law for the International Lawyer, US Corporate Law for the International Lawyer, and International Business Transactions & Agreements
