In my role as an associate lecturer, I am tasked with fulfilling three primary responsibilities: teaching, research. consultancy/extension. Let me elaborate on my activities within del each of these duties.

Since the first semester of 2017, I have been instructing the "General Principles of Public International Law" course at the undergraduate level. Starting from January 2020, I introduced the COIL method (Collaborative Online International Learning) as an academic innovation. Under this approach, the class is jointly coordinated by my home institution, Universidad del Rosario, and the Universidad de Monterrey in Mexico.

Throughout the semester, we conduct joint sessions with the participation of both Mexican and Colombian students. This course, which is mandatory and conducted entirely in English, provides students with fundamental concepts and foundational knowledge to comprehend international law.

Additionally, since the first semester of 2018, I have been teaching the course "Special Regimes of Public International Law" to undergraduate students. The objective of this course is to enable students to delve deeper into the various regimes within the fragmented system of international law. This course is also compulsory and is conducted entirely in English.

Since the first semester of 2018, I have been delivering lectures at the postgraduate level on "International Economic Law." In this module, students acquire a comprehensive understanding of International Trade Law (WTO system) and International Investment Law.

Furthermore, since the first semester of 2018, I have been leading a module on "Relevant Aspects of International Economic Law" for doctoral students. In this academic forum, we discuss contemporary and ongoing issues related to investment and trade law.

Research:

Starting from July 2016, I have taken the lead and actively participated in several research projects focusing on the following areas:

- i) Teaching and learning International Law in Latin America;
- ii) International Investment Law;
- iii) Business and Human Rights;

I currently serve as the Chief Editor of the academic journal Estudios Socio-Jurídicos. Previously, I was the Director of the Faculty's Research Office from August 2017 to January 2022 and led the Research Group on International Law at the Faculty of Law from August 2019 to August 2022.

This involves conducting an in-depth analysis of landmark cases to identify key precedents and trends, as well as performing thorough research using a wide range of secondary sources, including academic literature, legal documents, and reports from international organizations. My work requires synthesizing complex information to provide a comprehensive and well-founded framework that can guide assessments and policy recommendations in this critical area.

As an expert legal consultant specializing in international human rights, I advise the team on relevant legal matters and contribute to the foundational preparation for the USAID-funded project Inspirapaz in Colombia. The primary goal of this project is to enhance the capacities of institutional and civil society organizations in preventing human rights violations and protecting human rights defenders in Colombia. My key contributions include providing expert legal analysis, ensuring alignment with international human rights standards, and offering strategic guidance to strengthen the project's impact.

As a visiting researcher, I actively participated in academic seminars and contributed to ongoing research discussions at the host institution. During this period, I authored a book chapter titled "Community of Practice and the Ius Constitutionale Commune en América Latina," which explores the role of communities of practice within the Inter-American Human Rights System. The chapter was published in January 2025. My time at the Max Planck Institute for Comparative Public Law and International Law (MPIL) provided a valuable opportunity to deepen my understanding of regional human rights mechanisms and to engage with an international community of scholars working on critical issues in international law and human rights.
