

**Banking & Financial Law Program
Residential Final Exam Schedule
Fall 2025**

Timed exams are all 4 hours long (unless approved for extra time by the Banking & Financial Law Program). **For residential students**, they will be taken in a designated room at the time the time and date the exam OPENS. If given extra time, you will receive a separate email with the room assignment. You will use Exemplify, a software downloaded from the ExamSoft website, to take your exam. Exemplify may lock your computer for the duration of the exam, so you will not be able to access the internet or files on your computer. Specifications for each exam will be sent out via Blackboard announcement.

Take home exams have a window of 2-14 days. There is no time limit and no special software is required. You will download the exam file as a PDF document from the ExamSoft website, and upload your completed exam as a Word document to the ExamSoft website before the deadline.

The BFL Academic Regulations permit **timed exams only** to be rescheduled under the following circumstances:

- 2 exams scheduled in the same 24 hour period
- 3 exams scheduled in 3 consecutive 24 hour periods
- 4 exams scheduled in 4 consecutive 24 hour periods

Take home exams cannot be rescheduled.

If your schedule meets any of the above criteria and you wish to reschedule an exam, please contact the BFL office. **DO NOT contact your professor with a request to reschedule or extend an exam.**
