

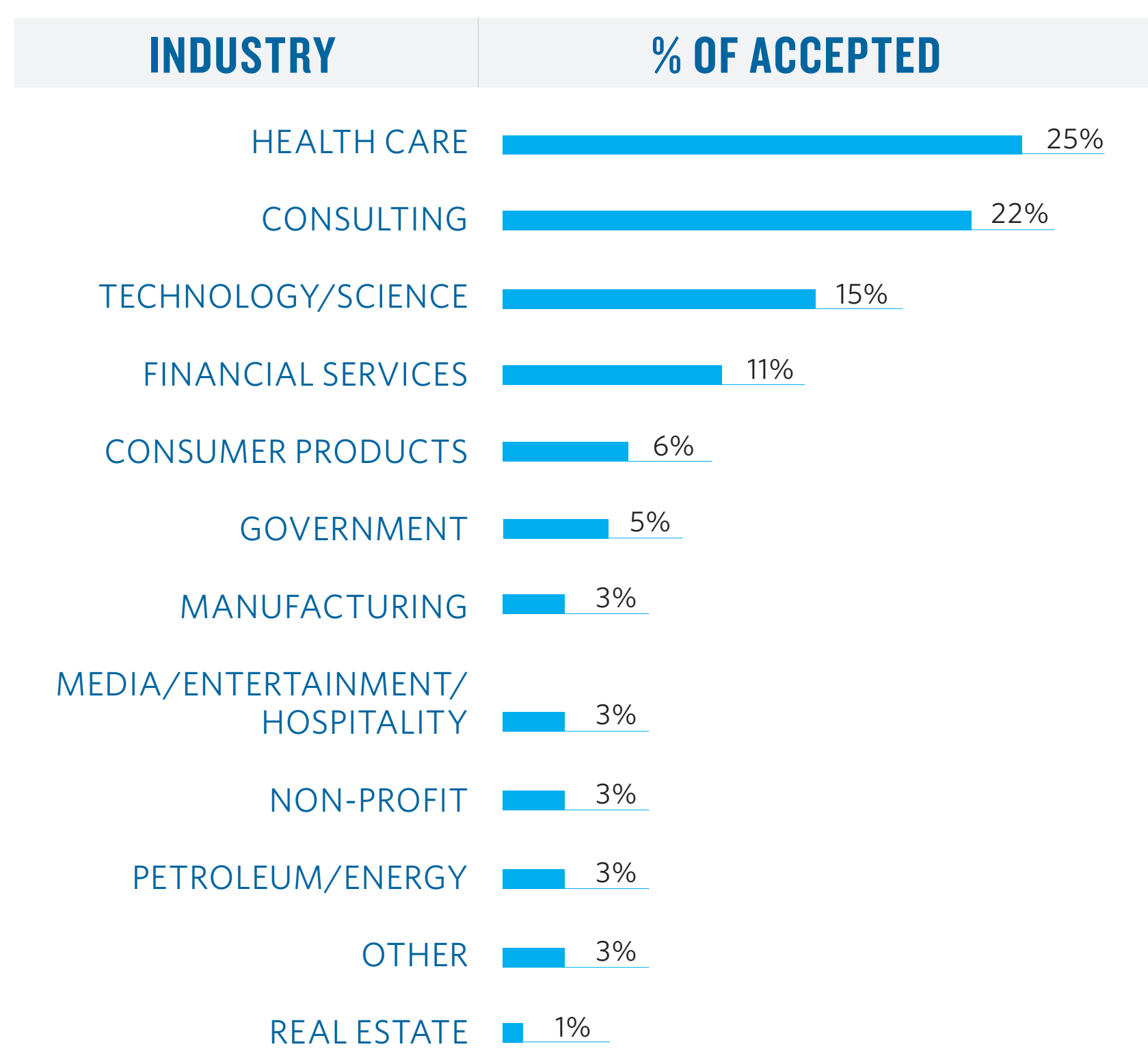

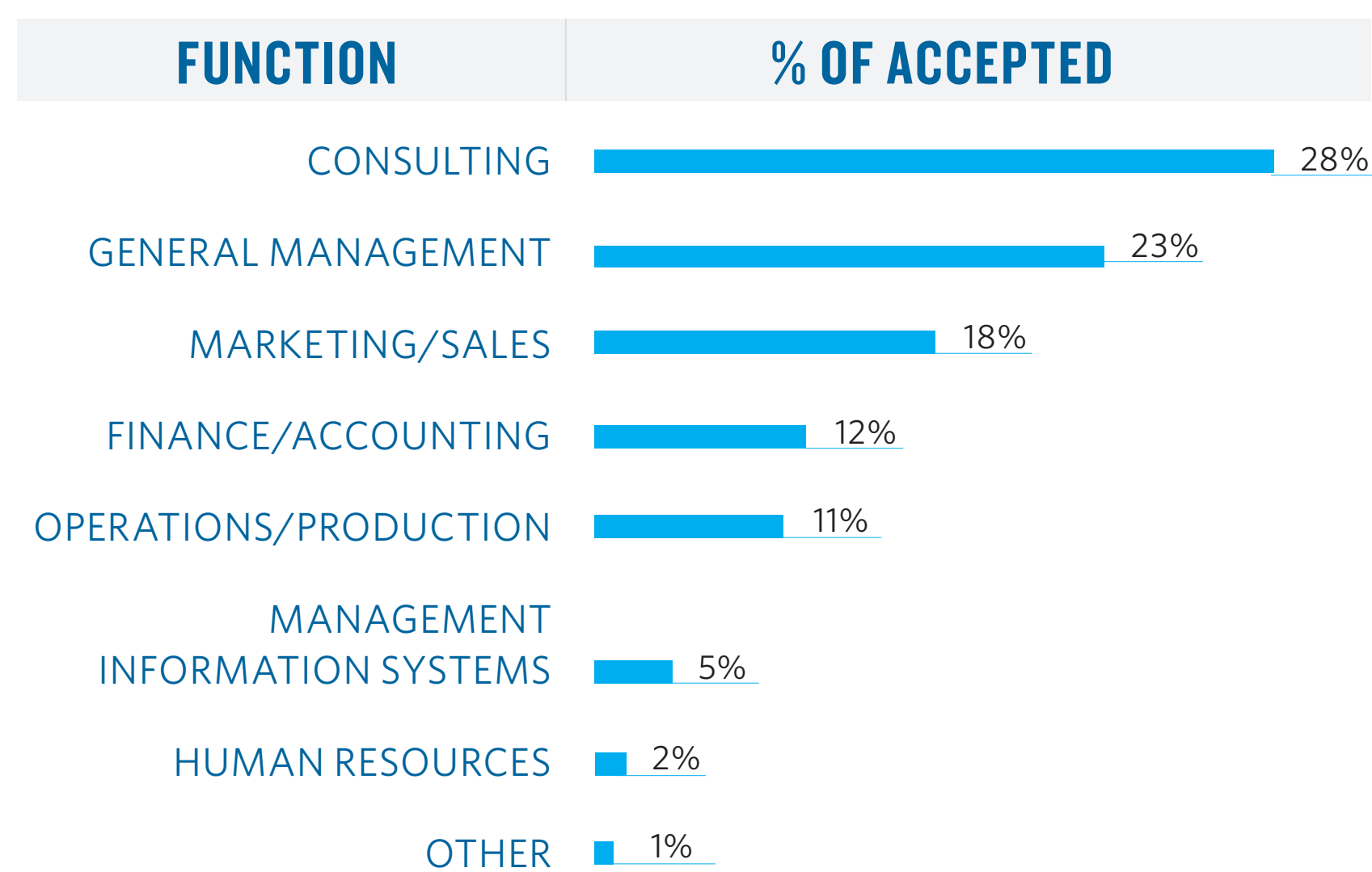
EMPLOYMENT BREAKDOWN

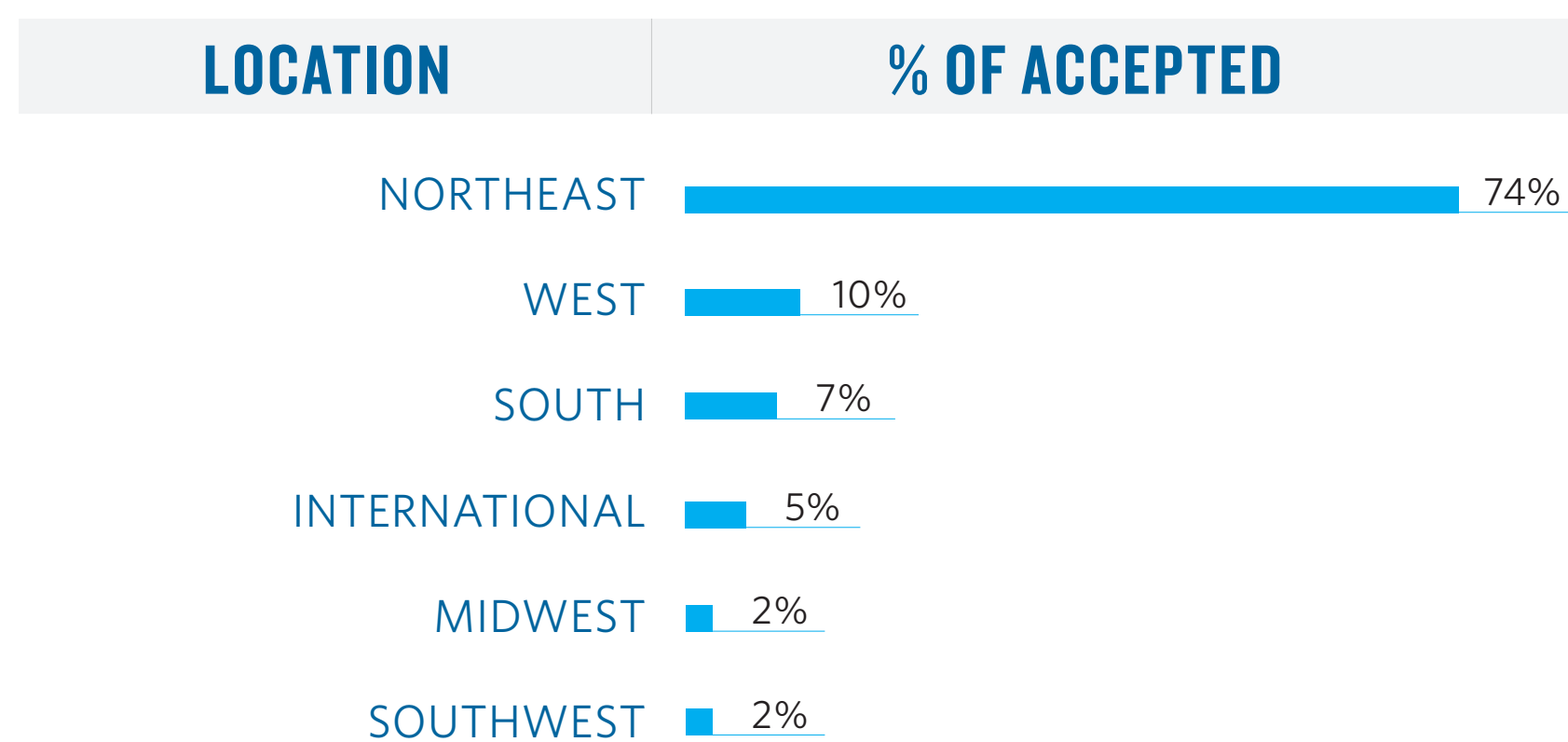
EMPLOYMENT BY INDUSTRY
