

# Background

- The changes to the GPS are a result of two government oversight audits.
- A Notice regarding this change was 1<sup>st</sup> issued in May.
- The September notice replaces the May notice.
- The September Notice cleared up many questions left unanswered since May

# Added Language

For foreign subrecipients, a provision requiring the foreign subrecipient to provide access to copies of all lab notebooks, all data, and all documentation that supports the research outcomes as described in the progress report, to the primary recipient with a frequency of no less than once per year, in alignment with the timing requirements for Research Performance Progress Report (RPPR) submission. Such access may be entirely electronic.

## **Overview:**

#### Timeline

- This requirement goes into effect on January 1, 2024.
- Boston University has 60 days to amend all affected subawards.

#### Access

- Lab notebooks, all data, and all documentation that supports the research outcomes in RPPR
- Electronic access is acceptable
- Access due date hooked to RPPR Report due date.
- Acknowledgement in LOI

### **Affected Subawards**

- NIH Prime Sponsor
- Subrecipient is a foreign entity.
- Active obligation period as of 1/1/24
- A report of applicable subs is in the works, and will be distributed by Department soon.

# Summary

- Our internal process is under development, and we are expecting to move forward with amendments beginning late Fall.
- Once a list of all subs is finalized, we will distribute by department.
- NIH expects recipients to ask potential subrecipients, **at the application stage**, to submit language in their letters of support indicating their awareness of these requirements and the subrecipient's willingness to abide by all requirements should an award be issued.

- Sponsor Draw and Invoice Deadlines
  - Ensure expenditures get onto accounts in a timely manner
  - BU is held to Sponsor Deadlines such as:
    - "Invoice within 60 days of end date" for pass thru Sponsors
    - Accounts on Letter of Credit (LOC), total expenditures need to be confirmed with your Post Award Officer within 75 days of end date to ensure we can draw remaining balances accordingly
