#### ANNA HOWARD SHAW

When I walk into the Anna Howard Shaw Center, I cannot help but think of the great contrast between BUSTH now and the days when Anna Howard Shaw was a student here. In her autobiography The Story of a Pioneer, she wrote that before she had been a member of her entering class (42 men and herself) an hour, she realized "women theologians paid heavily for the privilege of being women." Since there were no dormitory or eating facilities for women, she lived in an attic room on Tremont Street, her diet consisting primarily of milk and crackers. She attended classes on the third floor and was frequently too weak to climb the stairs without sitting to rest. Later, an unknown benefactor through the Women's Foreign Missionary Society paid her \$3.50 a week to rest, study, and care for her health.

Anna Howard Shaw's first pastorate was the Methodist Church in Hingham, MA, where she served a year. Then followed a seven year yoked pastorate in Dennis and East Dennis on Cape Cod. She sought ordination in the Methodist Episcopal Church and was rejected; in 1880, after lengthy conversation, she was ordained in the Methodist Protestant Church. She returned to the Cape to find a lovely communion set, an ordination gift from her parishioners.

Only five feet tall, blest with "superabundant vitality" and an "iron constitution", Anna Howard understood her call as necessitating a ministry to body as well as soul. She entered Boston University School of Medicine and received her M.D. in 1885. Encouraged and enabled by colleagues fighting the great battles for sufferage, temperance, and social purity, she recognized that her call was to an even wider ministry. "Deep in my heart", she wrote, "I realized the needs of the outside world, and heard its prayer for workers." She resigned from her parish and began to utilize her considerable speaking skills for women's



sufferage in the Boston area. Later, encouraged by her friend Susan B. Anthony to lecture for the National American Woman Sufferage Association, she criss-crossed the country as valiently as any circuit rider. She served as president of the National American Woman Sufferage Association from 1904-15. Her later years were spent organizing and mobilizing on behalf of the US during the 'Great War' and working on behalf of the League of Nations for peace.

In a sermon in 1893, she said "unless womanhood is developed, one-half of divinity itself is kept from the knowledge of the peoples of the world." She worked throughout her life to bring women and men nearer to a full understanding and appreciation of humanity.

#### UPCOMING EVENTS

WOMEN AND THE WORD: Experiencing the Uniqueness of Women's Preaching (This two day workshop, March 14-15, will be sponsored by the Anna Howard Shaw Center.)

Women rarely have the opportunity to hear other women preach. Women and the Word was born out of the desire of clergywomen to hear one another preach and to discuss those things distinctively feminine in the style, subject matter and focus of their preaching. Women and the Word seeks to identify the uniqueness of women's preaching, to provide support and training, and to affirm women's styles of preaching.

The seminar will include focused workshops on specific aspects of preaching, spirit and style, presentations by selected preachers, worship services, and celebrations.

Topics for the seminar will include: discovering the center of preaching, women's exploring the personality. ofpreaching, women's examining the environment of women's preaching, and reflecting theology of women's preaching.

Reverend Rebecca Wilson Dolch of Western New York UMC Conference will offer her rich experience and gifted expertise as resource leader for Women and the Word. #### MEET MARGARET WIBORG

The women at Boston University School of Theology are privileged to have a wonderful role model in Anna Howard Shaw. This fall, another positive role model entered our lives in the form of the AHSC's new director, Margaret Wiborg. Margaret comes to the School of Theology with a long history of work in Christian Education, the civil rights movement, church work, and women's groups.

Originally from Cary, North completed she did undergraduate studies in Religion at University in 1962. College. vacation work as the Director of Christian Education at an East Harlem church enforced the direction of earlier calls to ministry. After a second summer in East harlem, she attended Union Seminary and earned a Master's degree in Religious Education (1965). While at Union, she lived and worked at Five Points Mission, Church of the People, on the Lower East Side. work involved after-school and youth programs with a diverse ethnic makeup. She also worked in the church's summer camp at Cornwall-on-the-Hudson.

Following participation in a World Council of Churches summer workcamp in Lausanne, Switzerland, Margaret and her husband, Dick, moved to New Haven, CT, where Dick was appointed to two churches: a dying white church in a black community and a predominately black church in a housing project; the two eventually merged. Margaret was part of the corporate ministry of the Wider City Parish in New Haven where her major responsibility was to direct the progressive pre-school program. At the same time, she helped to develop a comprehensive Christian Education program at Summerfield Church.

One of the most edifying experiences for her at this time was a Women's Forum at the Summerfield Church. This group drew women from the church and the community and is still active in New Haven today. The support provided here enabled single mothers to pursue college educations and women from different socio-economic groups develop trust and sisterhood.

In 1979, the Wiborgs with their two sons Christopher (now 17) and David (now 14), moved to Boston where Dick was appointed SNE United Methodist Conference Council Director. Margaret

taught at a private pre-school ir Brookline and took courses at BUSTH.

Her appointment as Director of the AHSC in September, 1984, is only one of the responsibilities Margaret holds. She is also teaching a course entitled "Women in Parish Ministry", participating in the development program for women, serving as advisor for candidates in Diaconal Ministry, supervising two field education students, and working with the Sexism and Mutual Ministries Committees. addition, she is active in the Harvard Epworth United Methodist Church Cambridge, the SNE Clergy Wives Advisory Board, COSROW, and the Area Committee on the Episcopacy.

With Margaret's wise and loving leadership, the Anna Howard Shaw Center enjoying the celebration rejuvenation. Resources in the Center are increasing, as is student, lay, and clergywomen involvement. development for the Center as a network of communication and support between these women is a high priority Margaret's work. Margaret, like Anna Howard Shaw, is a small woman, filled with great energy and ability. We are blessed by the presence contribution of them both.

Women's Reality An Emerging Female System in the White Male Society. Anne Wilson Schaef. Winston Press, 1981. Book review by Peggy Huff

When I was asked to review Anne Wilson Schaef's <u>Women's Reality</u>, I readily agreed. It seemed only fair; I had been recommending the book ever since I read it last summer. An unexpected benefit from this use of my Christmas break were the additional insights I gained from this, my third, reading of the book. Therefore, I will henceforth not only recommend <u>Women's Reality</u>, I will urge that it be read and re-read!

Schaef begins by describing what led her to write this book, that is, a realization of the limitations of traditional psychology in understanding and helping women. Her search for better understanding led her to the recognition of what she calls the White Male System as the system in which we all live, and the concurrent existence of alternative systems, among them being both the reactive female system and the Female System. She maintains that understanding women requires one to understand all three systems, as well as the particular woman in her individual relationship to the systems. She takes interpersonal psychology a necessary step forward by clearly explicating these systems, particularly as they influence us in our culture. Comprehending these systems as systems facilitates the possibility for change, both for an individual and for the systems themselves.

Schaef describes first the White Male System, then the reactive female system. The reactive system is the system women have used for coping with the White Male System. She then discusses "Stoppers," ways the White Male System has for preventing women from moving into either the White Male System or the Female System.

The fifth chapter is a comparison of the Female System and the White Male System. While the comparison is primarily between these two systems, examples from other systems (Black, Chicano, Native American) indicate her awareness of of the value in more than the three alternatives. In fact, in the discussion of dualism in the next chapter she explicitly states that

she chose the dualistic approach because she felt that it was efficient and worked, not because it was inevitable (p.149). This sixth chapter praises paradox, denies the inevitability of dualism, and discusse levels of truth.

The final chapter, "An Introduction To Female System Theology," is perhaps the most provocative, in that while the other chapters describe what we have observed and/or experienced, this chapter invites thought in the area of theology. Her observations are those of a psychologist who realizes the role theology plays in ou culture, who has read liberation and feminist theologians. She asks questions for these theologians to explore, as we recognize White Male System Theology for what it is.

Schaef writes in a very accessible style, using illustrations from both her private practice and her consultant work. Her conversational style makes it easy to understand the ideas she presents. Her presentation is fair and even-handed, affirming the value of aspects of the Whit Male System for certain situations even as she presents the alternative of the Female System as preferable for others. The plea is for openness, process, and creativity, rather than closure, stasis, and sameness. Her position is that no one system is always best, and that all systems--White Male, Female, Black, Chicano, Native American, and others-- can benefit from on another.

#### MEN AND WOMEN IN DIALOGUE

An overnight retreat, sponsored by the BUSTH Office of Student and Community Life, entitled Men and Women in Dialogue, is scheduled for February 22-23, 1985 at St. John's United Methodist Church in Watertown. This event will begin Friday at 5:30 p.m. and conclude at 3:30 p.m. on Saturday. Carol Pierce and Richard Orange will lead the workshop and discussions.

This will be an important opportunity for members of the School of Theology community and their spouses or significant others to dialogue about problems and issues which may prevent effective working relationships between men and women.

We hope that discussions in the workshop will stimulate the development of ideas and skills which can be applied to similar situations in the communities in which we will participate when we leave STH.
