Doctoral Committee Meeting Minutes

July 28, 2022

1. New member

- a) Katie Hoskins has joined the admissions team as an assistant director
 - She will be leading the admissions process for all doctoral programs and any questions regarding admissions and applications should be brought up to Katie directly
- 2. Admissions process/timelines
 - a) Application opens on August 16
 - i. **ACTION**: If admissions committees have new members reviewing applications let the admissions office know who they are
 - b) Proposed application review timeline
 - i. First batch of applications will be sent on November 11 (any applications submitted and verified by that date)
 - ii. Second batch will be sent on December 1
 - iii. Third and final batch of remaining applications (submit by December 1 deadline) will be sent on December 15. This is a two-week grace period for those who are still waiting for verification. This date is not communicated to students.
 - iv. **ACTION:** Program directors to let the admissions office know if applications will be initially assigned to the program staff or directors
 - c) Anyone who officially reviews an application will need to provide a comment/note on the application in WebAdmit
 - d) Admissions reminds committee that no one should be reviewing incomplete applications, even if the applicant is only waiting for letters of recommendation
 - e) HSR noted concerns with the time given to review applications, time needed for reviewing is being shortened and can cause burnout among the application review committees
 - f) There are concerns regarding the wait time for the third batch of applications
 - i. Epi proposed to remove the grace period and make sure everything is submitted by December 1; then they would no longer need to wait until December 15 for the third batch of applications
 - ii. DrPH points out that verification can take longer for international students; proposes that we should not remove the grace period but should review all applications that were submitted by the December 1 deadline

- iii. **ACTION:** Admissions office will look into the data of previous applications periods to determine how long it takes prospective students to complete and submit their applications
- g) Admissions also notes that we cannot move the application deadline
 - i. Other schools have a December 1 deadline and if BUSPH's application is due sooner than other institutions, they might not make our deadline and apply only to other schools
- h) Biostatistics program directors incorporated an application review rubric directly in WebAdMIT, program directors would like to know how they can do the same
- i) Question: Can the APAs or directors provide one summarized final note from the multiple comments/notes left by reviewers?
 - i. Yes, a summarized note can be submitted for reviewed applications
- j) Doctoral student teaching
 - i. APR reviewers noted that BUSPH may be missing an opportunity by not requiring doctoral student to teach during their respective programs
 - ii. **ACTION**: Committee members will consider incorporating teaching opportunities and trainings, including PhD Progression: Teaching Skills offered by Office of Professional Development & Postdoctoral Affairs

3. Doctoral funding

- a) The university <u>funding page</u> for PhD students indicates 5-years of support for CRC programs (and refers SPH and GMS students to the respective program pages.
- b) HSR page indicates 4 years of funding, EH and EPI are vague in terms of funding duration
- c) Programs may want to be more specific for recruitment purposes
- 4. Graduate Council updates
 - a) Dissertation approval signatures during COVID, digital signatures made things easier, so the University will be piloting DocuSign services for a few of the programs to evaluate its effectiveness
 - b) PhD profiles pages are live on the BU website
 - i. **ACTION**: Review updated PhD profiles: https://www.bu.edu/grad/why-bu/phd-program-profiles/

5. RCR trainings

- a) Students have asked if they can have an exception to this requirement, or if other certifications from previous employers can be used to fulfill the requirement
 - i. **ACTION:** Lisa will ask Graduate Council if there are any exceptions to RCR training requirement
- 6. Program guides, competency maps
 - a) Competency maps will be revisited soon. These will be sent to the program directors and updated versions should be returned to Amanda Velez
