 - Changes to the VR-12 and/or VR-36, including without limitation changes to the wording and order of the questions and scoring algorithm, may not be made without our written permission. To the extent that you make any changes to the VR-12 and VR-36, you may not refer to the modified tools as "VR-12" or "VR-36" in any oral communications or written publications.
