The standard calendar for field education allows for two weeks off from field between each semester. Students may use this time to make up missed time due to illness or severe weather. The student's schedule for meeting the required number of hours should be written in the learning contract and documented in the field education time log or other tracking calendar. Students should also inform their advisor of any deviation from the schedule.

The University, in scheduling classes on religious holidays, intends that students observing those holidays be given ample opportunity to make-up the work. Faculty members who wish to observe religious holidays will arrange for another faculty member to meet their classes or for canceled classes to be rescheduled
